Rear fence Policy and Guidelines

The following is intended to be a guideline for the approved location and installation of fencing at Vineyard Grove. Please adhere to the following guideline:

All fences must be approved prior to any work starting on any fence in the community that is installed by a unit owner or owner contractor.

Instructions for Approval

- Complete all necessary paperwork and/or inspections required by the City of Lebanon.
 http://www.lebanontn.org/ No fences will be approved without proof of permit from City of Lebanon.
- 2. Complete and submit Architectural Change Request "ARC" through the Synergy Website. Must include approval from Lebanon. Please go to www.sregtn.com, go to <u>HOA Members</u> and choose <u>Architectural Request for</u> Change Form from the dropdown.
- 3. ARC requests must include a plot plan with location of the home and distance from property lines and drainage easements
- 4. Once approved or denied, you will be notified through your portal.
- 5. Once notification for approval is received, you may begin construction.

Installation and Type Guideline

Note: Only the fences outlined below are permitted and can be approved according to the guidelines herein.

1. Wood

- a. 6 Ft. height only
- b. Dog Eared Privacy in design (pictured below)
- c. Red Cedar or Treated Pine
- d. Must be stained using only the following Sherwin Williams semi-transparent stains:
 - i. Hill Country
 - ii. Harbor Mist
- e. Example of approved wood fence pictured below (this style only):

2. Black Aluminum

- a. Minimum 4 Ft. in height Maximum 6 Ft. in height only
- b. Open spindle only
- c. Example of approved black aluminum fence pictured below (this style only):



3. White Vinyl

- a. 6 Ft. height only
- b. Privacy only (pictured below)
- c. Example of approved white vinyl privacy fence pictured below (this style only):



Important Notes

- 1. Fence shall not extend past property line.
- 2. Fence along side of home must be less then 49% the length of the home (nearer to the back than the front).
- 3. Limit two gates not to exceed 4 ft. in width
- 4. It will be the responsibility of all owners to call Tennessee One-Call and any utilities not a part of Tennessee One-Calls system to locate utilities before digging.

- 5. It will be the responsibility of all owners to ensure fences are within their property lines. Surveys are the responsibility of the owner.
- 6. Chain Link Fences are not permitted.
- 7. Three-Rail Fences are not permitted.
- 8. No specific vendor is required.
