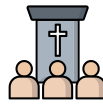

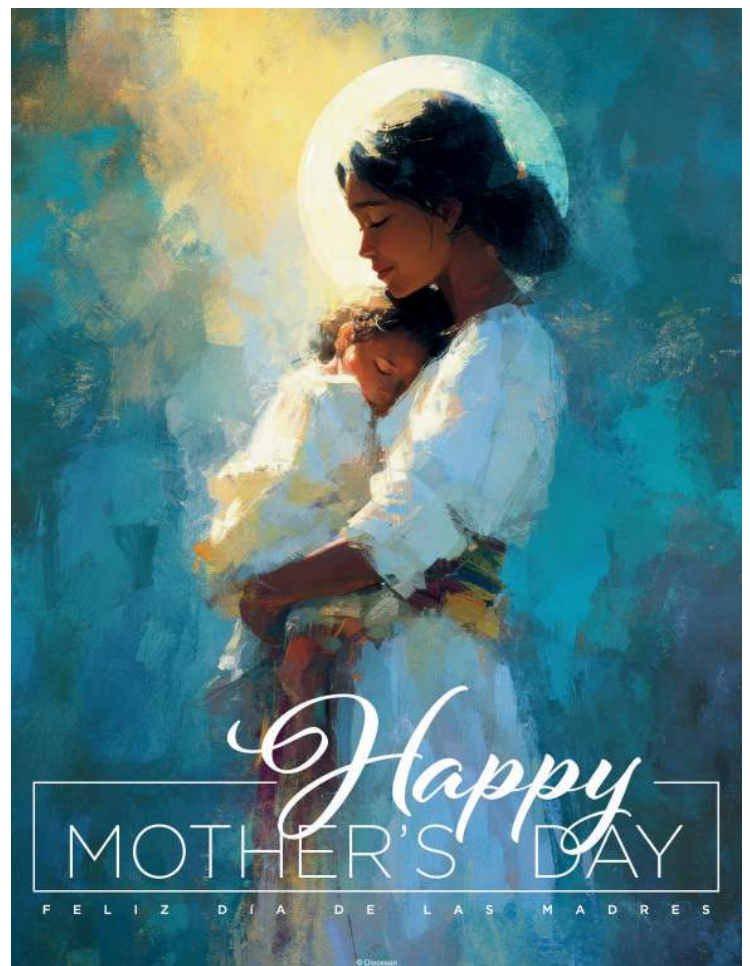

### Stewardship

Stewardship becomes a concrete expression of that love when we give of ourselves for the good of others.

*"... sanctify Christ as Lord in your hearts. Always be ready to give an explanation to anyone who asks you for a reason for your hope."* 1 Peter 3:15

Actions speak louder than words. Let your stewardship be your reply. Stewardship involves a change of heart, embodied not just in a single action, nor even a series of actions, but in a way of living.

### Gospel Reflection

John 14:15-21

Today's Gospel is a continuation of last week's Gospel: Jesus is speaking to his disciples at the Last Supper. In today's reading Jesus offers encouragement to his disciples, who will soon see him crucified. He reassures them that even though he will leave them, he will not abandon them. Instead he will send them the Advocate, the Holy Spirit, through whom the disciples will continue to live in union with Jesus.

Jesus uses the term Advocate to describe the Holy Spirit, whom the disciples will receive. Another word used to describe the Holy Spirit is Paraclete, a legal term meaning "one who offers defense for another." Note that Jesus says that he will send "another Advocate." Jesus himself is the first advocate, interceding for his disciples with the Father.

In today's reading Jesus contrasts his impending departure with the permanence of the gift of the Holy Spirit. Jesus will leave to return to the Father, but the Holy Spirit will remain with the disciples.

Through the gift of the Holy Spirit, the disciples will come to know and appreciate the unity of the Son and the Father. They will also understand that they too participate in the communion between the Father and the Son: "On that day you will realize that I am in my Father and you are in me and I in you" (John 14:20).

Today's reading is one example of the contrast that John's Gospel presents between the community of disciples, to whom God will reveal himself, and the unbelieving world, which will remain in darkness. The unbelieving world cannot accept the "Spirit of truth," whom the disciples will receive. Only through the Spirit will God's revelation and love be known.

### Mayordomía

La corresponsabilidad se convierte en una expresión concreta de ese amor cuando nos entregamos por el bien de los demás.

*"Veneren en sus corazones a Cristo, el Señor, dispuestos siempre a dar, al que las pidiere, las razones de la esperanza de ustedes"* 1 Pedro 3:15

Las acciones dicen más que las palabras. Deja que tu mayordomía sea tu respuesta. La mayordomía implica un cambio de corazón, que no se plasma solo en una acción aislada, ni siquiera en una serie de acciones, sino en una forma de vida.

### Reflexión del Evangelio

Juan 14, 15:21

El Evangelio de hoy es una continuación del Evangelio de la semana pasada: Jesús habla a sus discípulos durante la Última Cena. En la lectura de hoy, Jesús ofrece aliento a sus discípulos, quienes pronto lo verán crucificado. Les asegura que, aunque los dejará, no los abandonará. En su lugar, les enviará al Abogado, el Espíritu Santo, por medio de quien los discípulos continuarán viviendo en unión con Jesús.

Jesús utiliza el término "Abogado" para describir al Espíritu Santo, a quien los discípulos recibirán. Otra palabra utilizada para describir al Espíritu Santo es "Paráclito", un término legal que significa "aquel que ofrece defensa en favor de otro". Nótese que Jesús dice que enviará a "otro Abogado". Jesús mismo es el primer abogado, intercediendo por sus discípulos ante el Padre.

En la lectura de hoy, Jesús contrasta su inminente partida con la permanencia del don del Espíritu Santo. Jesús partirá para regresar al Padre, pero el Espíritu Santo permanecerá con los discípulos.

Mediante el don del Espíritu Santo, los discípulos llegarán a conocer y apreciar la unidad del Hijo y del Padre. También comprenderán que ellos mismos participan en la comunión entre el Padre y el Hijo: "Aquel día comprenderán que yo estoy en mi Padre, y ustedes en mí, y yo en ustedes" (Juan 14:20).

La lectura de hoy es un ejemplo del contraste que el Evangelio de Juan presenta entre la comunidad de los discípulos - a quienes Dios se revelará - y el mundo incrédulo, que permanecerá en la oscuridad. El mundo incrédulo no puede aceptar al "Espíritu de la verdad", a quien los discípulos recibirán. Solo a través del Espíritu se darán a conocer la revelación y el amor de Dios.

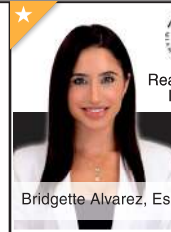
