Official Rules

Sponsor: The raffle is sponsored by the Maria Mitchell Association (MMA), a nonprofit organization located in Nantucket, Massachusetts. Proceeds support MMA's general operating expenses.

Raffle Permit #: 41-2026

Prize Description: Ultimate Nantucket Adventure Package featuring a Japanese Domestic Market Honda Acty Kei Truck (4WD). Chassis No.: HA4-2372752. Mileage: 87,586 km (approximately 54,424 miles). The vehicle has recently received routine service and cosmetic upgrades. Vehicle is awarded as-is, where-is, with no warranties expressed or implied by MMA or Ocean City Honda. **Fair Market Value of Full Prize Package: \$15,000.** The vehicle is available for inspection at the point of ticket sale.

Tickets: Tickets are \$100 each or six (6) tickets for \$500. Maximum tickets available: 300. Tickets must be purchased in person; tickets will not be sold or distributed by mail. There is no minimum number of tickets required for this raffle to proceed. Raffle ticket purchases are not tax-deductible charitable contributions. All ticket sales are final.

Drawing: Sunday, July 26, 2026, at Tom Nevers Field at 4 pm. The winner does not need to be present to win.

Eligibility: Participants must be 18 years of age or older. MMA employees, members of the Board of Directors, and members of their immediate households are not eligible to participate.

Taxes: Winner is responsible for all applicable federal, state, and local taxes. Required federal and Massachusetts withholding of up to \$4,320.00 (24% federal plus 5% Massachusetts of the prize value, less applicable reduction for the cost of the winning ticket(s)) must be paid to MMA before prize release. MMA will report the prize and the amounts withheld to the IRS and the Massachusetts Department of Revenue and will issue the winner an IRS Form W-2G. Before the prize is released, the winner must furnish a completed IRS Form W-9 and two forms of identification, one of which bears a photograph. Winner is also responsible for Massachusetts use tax (assessed on the vehicle's value at the time of registration), title, registration, insurance, and other costs associated with accepting and owning the vehicle.

Prize Acceptance: The winner must complete the required prize acceptance documentation by August 3, 2026. Vehicle transfer must be completed by August 25, 2026, unless otherwise agreed upon by MMA. If the winner does not complete the required prize acceptance documentation and tax withholding payment by August 3, 2026, the prize will be forfeited, and another winner will be selected from the remaining eligible entries.

The vehicle will not be released until all required tax withholding, documentation, title transfer, registration, and insurance requirements are complete.
