Tax volunteers gathered to celebrate a successful tax season in 2024. A total of 11 volunteers processed over \$800,000 in property tax credits, rent rebates and income taxes. Those in attendance represented 63 vears of volunteering in the Tax Counseling for the Elderly program through InterServ.

Missouri Department of Health & Senior Services held a Town Hall meeting at InterServ Community Center in 2024 to address Missouri's Master Plan on Aging.






The Guadalupe Center High School Weightlifting team participating in the 2024 Pony Express Open.

2024 Service Statistics

In 2024 InterServ provided 15,111 people with a total of 152,255 units of service.

8,771 days of care were provided at our Mitchell Woods Preschool and Early Education Center.

10,247 participant days of 21st Century Schools activities, recreation, weightlifting and youth programming provided at Southside Youth.

2,293 units of Friday night youth activities, sports team practices, pickleball at the InterServ Community Center.

182 people received assistance in the areas of budget management, aging counseling and housing case management. 214 Referrals for homeless households were made for housing.

6,970 Family Food Orders were provided to feed 11,275 people.

\$331,968 of direct financial assistance was provided to those in need of housing and stabilization.

18,812 meals were served at our two Senior Neighborhood Centers. Volunteer drivers delivered 71,383 meals in the Mobile Meals Program. A total of 7,850 meals were served to afterschool youth. In all, 98,045 meals were provided to our community.

5,449 total hours of volunteer services were provided to the community through RSVP (Retired and Senior Volunteer Program-age 55+) and other volunteers.

Tax Counseling for the Elderly volunteers prepared 1,875 Federal, State and Property Tax Credit returns for elderly and low income persons generating \$883,182 in refunds.

14,626 hours of Homemaker and Consumer Directed Services assisted elderly people to remain living in their own homes rather than being placed into nursing homes or more restrictive environments.

InterServ convened 37 meetings or events concerning social justice and community issues.
