
# a) Building and Grounds

# (1) Report:

(a) The state came to do a boiler inspection. They found a ground wire issue which was fixed by Heartland. They also found a leak in a door. Heartland is looking into this further.

### b) Finance: Kaysee

- (1) Month-to-month we are tracking well so far this year.
- (2) HOPE dinner gross was more than projected. We will have a final number once all expenses have been accounted for. Thank you for your generosity.



(3) McCormick Estate- more of the estate has been settled and deposited in the endowment fund.

# c) Long Range Planning

- (1) The finance team met on Oct. 27 to plan and budget for the 2026/2027 school year. Based on our projections we should be able to hire an additional teacher for 5<sup>th</sup> grade.
- (2) Tuition increase: Finance committee agreed to increase tuition by 4% which is the same as last year.
- (3) Tech fees: The finance committee also discussed adding a \$100 tech fee for elementary students and \$150 tech fee for middle school students. The computer lab in the school only has three working computers. There is a need to have a technology fund to make necessary updates. Technology fees and policy will be discussed at the January meeting.

  - Adding to update the history of the academy to include the Zebedee center, new addition, and expansion of the middle school. We will have a second reading in January.
- (2) 1003- SJA Constitution and Bylaws- Chris read our St. John's Academy school board constitution and bylaws. recommendation to change number of board members from 10 to 9, non-parish board members from two to one, reorganization of officers will be done annually by vote at the August meeting instead of June meeting, and meetings should take place on the 3<sup>rd</sup> Monday of the month (except for December, June, and July). We will have a second reading in January.
