**Level 2 Asphalt Technician Requirements:**

To be approved as a Level 2 Asphalt Quality Control Technician by the Ohio Department of Transportation (ODOT) the following requirements must be met:

1. Successfully pass the Level 2 Asphalt Technician written exam.
2. Successfully pass the Level 2 Asphalt Technician (hands-on) practical exam.
3. Submit a current Radiation Safety Training certificate.

**Pre-Test Opportunity:** Individuals having the appropriate knowledge and experience wishing to schedule a Pretest may arrange to do so by contacting Steve McAvoy at (614) 275-1379 at the ODOT Central Laboratory. A score of 90 percent is required to pass the Pretest. If the Pretest is failed, the Level 2 Asphalt Technician School must then be attended before a retest will be allowed. The Level 2 Asphalt Technician training manual may be obtained from Flexible Pavements of Ohio (FPO) for study in advance.

**FPO Level 2 Training:** FPO offers this training course to prepare individuals having basic lab familiarity to take the ODOT Level 2 Asphalt Technician Exam. On the final day of the course, students will have the opportunity to take the ODOT written examination for Level 2 Asphalt Concrete Technician approval. Additionally, individuals will be scheduled for a practical laboratory exam.

**Students Will Learn:** Detailed information regarding ODOT's Quality Control (QC) and Quality Assurance (QA) program and testing requirements following the ODOT Construction and Material Specifications. This information is necessary to successfully pass the examination for ODOT Asphalt Concrete Technician Level 2 approval.

**Who Should Attend?** Asphalt contractor employees, engineering consultants and others seeking ODOT Asphalt Concrete Technician Level 2 approval and/or desiring technical knowledge of basic asphalt paving mixture quality control testing. In addition, pavement coring technicians may require this approval. ODOT employees should contact their training coordinator to arrange attendance to this training.

**Date, Time & Location:** October 29-31, 2025. The Asphalt Level 2 Technician training includes classroom instruction, a half day (4 hour) written exam and a lab practical test. The classroom training begins at 8:30 A.M. on October 29 and 8:00 A.M. on October 30. On successful completion of training, participants will take a lab practical and written exam administered by ODOT personnel on the third day. Students should bring a copy of ODOT's 2023 Construction

and Material Specifications Book, a non-programable calculator and pencils for completing calculations. The classroom instruction and written test will be held at:

Upon completion of the written exam the students report to the Ohio University Asphalt Lab (same floor and building-directions will be provided during the class) for the practical exam. **The lab practical** is approximately four hours in length.

Overnight lodging is not provided with this training but is available at hotels located in and near Lancaster, OH. Lunch breaks are scheduled but food and refreshments will not be provided with this training.

**Registration Fee:** \$610.00 per person for Flexible Pavements of Ohio members and \$670.00 per person for all others. The size of the class is limited as necessary for the examination and laboratory work. Registration will be on a first come, first served basis. FPO reserves the right to cancel the training if insufficient interest exists or to schedule additional session(s) if demand exceeds the accommodations. Payment method must accompany registration. Fee includes sessions and reference materials.

**Course Prerequisites:** In order to maximize the benefit of the class you must have previous hands-on experience with aggregate gradation, centrifuge extraction, maximum specific gravity and bulk specific gravity equipment. This prerequisite does not require testing proficiency but rather previous experience in using the testing equipment, and a basic knowledge of testing procedures. This minimal hands-on experience can be obtained through your employer or another source such as a contractor or consultant who performs the testing with the above-mentioned equipment. A brief letter from the owner of the testing equipment confirming this hands-on experience with the above-mentioned equipment (run a test to completion) is required before attending this training. This letter must be sent to Flexible Pavements of Ohio at least one week prior to attending the school. Failure to do so will result in loss of eligibility to participate in the training.

**\*\*\* ODOT LEVEL 2 ASPHALT TECHNICIAN APPROVAL PREREQUISITE \*\*\***

While it is **not required** to have completed the Radiation Safety Training Class before the attendance of a Level 2 Asphalt Technician Class or to take the Practical (hands on) exam, it is however **necessary** to have completed this safety training and have a copy of the Radiation Safety Certificate on file with the Asphalt Materials section of the Office of Materials Management at 1600 W. Broad St., Columbus, Ohio before an individual can officially be approved as a Level 2 Asphalt Technician.

The Level 2 Asphalt Technician training will only include classroom training on the use of a Nuclear Asphalt Content Gauge and the practical (hands-on) demonstration will not include the use of the part of the gauge which holds the radiation source.

**Cancellation Policy:** If a school participant needs to **cancel their reservation** in the Level 2 Asphalt Technician Training, they must do so **no later than five (5) working days** before the school in which they were scheduled takes place. Participants may be scheduled for another session if available or their registration fee will be refunded less a \$35 administration fee. Refunds will not be made to late cancellations or no-shows.

**NOTE:** ODOT will retain the completed written and practical Level 2 Asphalt Technician Exam results for a maximum of two months pending receipt of a radiation safety certificate. If ODOT does not receive the completed radiation safety certificate within that time period or have not received written knowledge as to the cause of the delay, the tests will be discarded and the complete class and exams must be retaken. If the Level 2 Asphalt Technician written test given at the school is failed, the test must be retaken within three weeks or the test will be discarded and the class must be retaken. The practical portion of the Level 2 Asphalt Technician Exam must also be completed within one month of successfully completing the written portion of the exam. Failure to do so will require a technician to retake the written test.
