*"Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent."*

The goods and services shown below are those we can provide to our customers. You may choose only the items that you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD.** This is the basic fee that we charge every family for our professional expertise in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes, but is not limited to, 24 hour availability of the staff to respond to the initial request for services, consultation with the family, administrative and clerical services, preparation of the death certificate for certification of the attending physician or coroner, necessary permits, filing of the death certificate with appropriate agencies, consultation with the clergy, cemetery or common carrier, assistance with insurance papers, planning the funeral, and placement of obituary notices. There will be a charge for each service requested or required. This fee for or basic services and overhead will be added to the cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Casket prices range from \$1010 to \$6880; and the RENTAL CASKET PRICE IS \$995. A complete casket price list will be provided at the funeral home. The ALTERNATIVE CONTAINER price range is \$95 to \$695. Three alternative containers are available for sale at the funeral home. **BASIC CARE SERVICES**

FORWARDING OF DECEASED TO ANOTHER FUNERAL HOME ..... (\$2,995) \_\_\_\_\_

This charge includes transfer of the deceased to our funeral home, basic services of the funeral director and staff, embalming and local transportation. Additional charges for selected merchandise and shipping charges will be applied. This charge does NOT include visitation, rites or ceremonies.

RECEIVING DECEASED FROM ANOTHER FUNERAL DIRECTOR ..... (\$2,995) \_\_\_\_\_

This charge includes basic services of the funeral director and staff, local airport transportation, care of the deceased, and transportation of the deceased to the cemetery for burial. This charge does NOT include visitation, rites or ceremonies.

**CREMATION SERVICES AVAILABLE FROM \$1,650 to \$9,100**

Our charge for a direct cremation WITHOUT ANY RITES, CEREMONIES OR VIEWING OF ANY KIND includes removal from place of death (local), transportation to crematory, necessary services of staff & equipment, securing necessary authorizations, refrigeration and cremation fee. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is cardboard.

PACKAGE "A" FULL TRADITIONAL CHAPEL SERVICE \$4,445.00

This fee includes basic services of the funeral director and staff, embalming, other preparation of the remains, use of facilities for viewing, use of facilities for funeral ceremony, transfer of the remains to the funeral home (within 30 mile radius), use of funeral coach, service vehicle and utility vehicle.

PACKAGE "B" FULL TRADITIONAL CHURCH SERVICE \$4,445.00

This fee includes basic services of the funeral director and staff, embalming, other preparation of the remains, use of facilities for viewing, facilitation of the funeral ceremony at a location other than the funeral home, transfer of the remains to the funeral home (within 30 mile radius), use of funeral coach, service vehicle and utility vehicle.

PACKAGE "C" GRAVESIDE SERVICE \$4,445.00

This fee includes basic services of the funeral director and staff, embalming, other preparation of the remains, use of facilities for viewing, facilitation of the funeral ceremony at the graveside, transfer of the remains to the funeral home (within 30 mile radius), use of funeral coach, service vehicle and utility vehicle.

PACKAGE "D" FULL TRADITIONAL CHURCH, CHAPEL OR GRAVESIDE SERVICE WITH ROSARY OR WAKE SERVICE \$4,445.00

This fee includes basic services of the funeral director and staff, embalming, other preparation of the remains, use of facilities for viewing, use of facilities for funeral ceremony, facilitation of the funeral ceremony at a location other than the funeral home, or facilitation of the funeral ceremony at the graveside, separate Rosary or Wake Service, transfer of the remains to the funeral home (within 30 mile radius), use of funeral coach, service vehicle and utility vehicle.

PACKAGE "E" FULL TRADITIONAL CHURCH, CHAPEL SERVICE WITH RENTAL CASKET FOLLOWED BY CREMATION \$5,250.00

This fee includes basic services of the funeral director and staff, embalming, other preparation of the remains, use of facilities for viewing, use of facilities for funeral ceremony or facilitation of the funeral ceremony at a location other than the funeral home, transfer of the remains to the funeral home (within 30 mile radius), use of funeral coach, service vehicle and utility vehicle, rental casket and crematory fee.

PACKAGE "F." CREMATION WITH MEMORIAL SERVICE \$3,655.00

This fee includes basic services of the funeral director and staff, refrigeration, use of facilities for memorial service or facilitation of the memorial service at a location other than the funeral home, transfer of the remains to the funeral home (within 30 mile radius), service vehicle and utility vehicle, minimum alternative container and crematory fee.
