Method of Payment

Payment for goods and services is expected at the time of arrangements, and required prior to services being rendered. For your convenience we accept cash, check, and all major credit cards are accepted with a 3% merchant fee. Assignments on life insurance policies will be taken on a case by case basis.

Federal Trade Commission Disclosures

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Except in certain special cases, Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral and viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials, (with or without outside covering). The containers we provide are fiberboard.

The fee for our basic **services and overhead** will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials, and forwarding or receiving remains).

Cremation will occur within fourteen (14) working days of receiving the permit for cremation from the county of death. Standard cremation is based on decedent being under 300lbs.

Itemized Arrangements

Professional Services

Basic Professional Services of Funeral Director and Staff \$1200

This is the basic charge to each family we serve for our professional expertise in assisting them. It includes, but is not limited to, a proportionate share of the taxes, licenses, utilities, and business expenses necessary to serve the public in a professional manner. Also included in this charge is the consultation with the family, clerical and administrative services, preparation and filing of necessary permits, consultation with the clergy, cemetery, crematory or common carrier, planning the funeral, and placement of obituary notices. There will be an additional charge for the direction and supervision of each service requested or required.

Refrigeration \$600

If embalming is declined and the final disposition of the deceased is not completed within 24 hours of the time of death, refrigeration is required by California State regulation, Title 16 Sec. 1223 (b). *Note: Our initial refrigeration fee includes 5 consecutive days. Beginning on the 6th day, the Funeral Home will charge \$100 for each additional day of refrigeration.*

Re-File of Disposition Permit (*plus actual permit fee*) \$75
