Our charge for a direct cremation includes local transfer of remains to funeral home, required authorizations, services of funeral director and staff, transportation of the body by livery to local crematory, and the return of the cremains to the funeral home. Transfer or other transportation by funeral home livery beyond a radius of 50 miles is subject to an additional charge of 3.25 per mile. If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the crematory charge.
