1. Promoter

- **1.3** All member deposits are protected under the Financial Services Compensation Scheme (FSCS) up to £85,000.

2 Eligibility

- 2.3 Participants must be 18 years or older.
- **2.4** Participants must be employed by Harlow District Council.
- **2.5**Employees of Plane Saver Credit Union, its Board of Directors, volunteers, and/or their immediate family members are not eligible to enter.
