PAYMENT POLICY

All payments are due the 1st class of the month. You may pay your account by Cash, Credit or Check. All payments setup on AutoPay will be processed to the credit/debit card on file on the 2nd of the month. The parent or guardian is responsible for notifying the Studio of any change to the credit card on file. The returned check fee is \$45. Tuition payments are non-refundable. Please Do Not leave cash at the front desk if nobody is there to accept it. A 10% late charge will be applied to unpaid account balances on the 15th of the month.

Should this provision have to be enforced by legal means, the undersigned person(s) is responsible for payment, as liquidated damages, the costs of collection, plus interest at the legal rate and reasonable attorney's fees as determined by the Court.

DANCE ATTIRE

We require the following dance attire for all classes: All students must wear hair up in ponytail. A leotard and tights are required for each class except Hip hop. Hip Hop students can wear sweat pants or comfortable clothing they can easily move in and clean sneakers not worn outside. Tap students – black tap shoes, ballet students - pink leather ballet shoes (not ballet slippers), jazz students – tan jazz shoes, acro students – footless tights. Students not wearing the appropriate attire and shoes will be given a notice by the instructor.

DROP OUT POLICY

We require a 2 week written notice if you choose to drop out of classes. (For example, if you drop out during any point of a month, you will be required to pay for that month's tuition.) An official withdrawal form must be completed and are available at the front desk to make any changes to your account. Until we receive written notification, you are responsible for any and all charges to your account regardless of your attendance to class. We are unable to give refunds. (We will of course make exceptions if there has been an injury of some sort, supported by a physician's note.) The payments are averaged over the 10 month calendar year, taking into account a 3 to 5 week month and including rehearsal and recital fees. When registering for the dance season you are registered for classes from September till June.

ATTENDANCE / CLASS MAKE-UPS

Children should arrive promptly and attend classes regularly. Keep absences down to a minimum for optimal learning. Make-up classes are not available; you will not be able to attend another class to make up a missed class for any reason. No refund for a missed class.

CANCELLATION OF CLASSES

Are non-refundable. Our cancellation policy is if the CNS school district is closed or implements an early dismissal due to weather we are closed. If the CNS school district has a one hour delay we are open, if the CNS district is on a 2 hour delay, evening classes will be held. Please check the CMC website or our Facebook page for class status.

COSTUME

A \$35 non-refundable costume deposit will be due by December 15th. Acro and Hip Hop each require a separate \$35 deposit for classes on Monday or Wednesday. Costume balances are due May 1st.

END OF THE YEAR RECITAL

In June we will have an end of the year recital. All students are invited to participate. If you do not plan to participate in the recital please notify the front desk. Each family will receive 2 complimentary tickets to the recital. If your tickets are misplaced or lost they will not be replaced.
