RULES IN REVIEW

Disputes between neighbors who share front or backyard property lines are civic matters between neighbors and should be discussed reasonably between parties until agreement or compromise can be reached. **The HOA** has recently fielded several complaints regarding fence damage caused by tree roots. It is the responsibility of the owner to repair any damage caused by tree(s) on their property. Rule 7.2

Reminder: The City of hurricane only allows a resident to have 2 dogs. Anything over 2 dogs requires a kennel license which is not allowed by HOA. Pet owners are responsible for their pet's waste and must pick up after their pet, in any Common or Limited Common area. Rule 5.2 and 5.4

No billboard or sign shall be displayed upon any Lot, except that a Lot owner can place a "For Sale" or "For Rent" sign not larger than two (2) feet by three (3) feet on his Lot. Rule 6.15
