News

WASHINGTON AND KANE COUNTY, Utah – Due to thunderstorms in Southern Utah, a flash flood warning has been put in place. A moderate, 2 out of 4, weather risk was set by the National Weather Service. Slot canyons, dry washes, and small streams are expected to see flash floods.

A wildfire sparked by lightning near the Utah-Nevada border late Thursday grew to nearly 6,000 acres on Friday, driven by winds and dry conditions into Washington County and sending a plume of smoke over much of the surrounding area. The Dodge Springs Fire was first reported just before 3 p.m. on Thursday, about 25 miles southeast of Caliente, Nev.

Washington County developers will soon need guarantees about water supply before building. It's an effort to help municipalities and developers manage a dwindling resource. "Will Serve letters" are a guarantee from the <u>Washington</u> <u>County Water Conservancy District</u> there's enough water to go forward with a project.
