DIRECT CREMATIONS:

Range of Prices **\$2,995.00 - \$4,829.00**

Our charge for a direct cremation includes local transfer of remains to funeral home, required authorizations, services of funeral director and staff, transportation of the body by livery to local crematory, and the return of the cremains to the funeral home. Transfer or other transportation by funeral home livery beyond a radius of **10 miles** is subject to an addition charge of **\$3.00** per mile.

If you want to arrange a direct cremation, you may use an alternative container, Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without and outside covering). The containers we provide are corrugated cardboard. Local crematories require a rigid container. The direct cremation prices do not include the crematory charge.

Our charge for an immediate burial includes local transfer of remains to funeral home, required authorization, services of funeral director and staff, transportation of the body by livery to local area cemetery. Transfer of other transportation by funeral home livery beyond a radius of **10 miles** is subject to an additional charge of **\$3.00** per mile. The direct burial prices do not include cemetery charges.

NOTE: In NYS, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements, such as a viewing or an open casket funeral, embalming may be required by the funeral home.

Transfer or other transportation by funeral home livery beyond a radius of **60 miles** is subject to an additional charge of **\$3.00 per mile**. Transportation by common carrier is not included in the above charge. The charge does not include any additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Receiving of Remains from another Funeral Home \$3,745.00

This charge includes local transfer of remains to funeral home, other necessary local transportation of the deceased by livery, required authorizations, services of funeral director and staff and necessary use of facilities. Transfer or other transportation by funeral home beyond a radius of **60 miles** subject to an additional charge of **\$3.00 per mile**. The charge does not include the cost of common carrier, additional items of service, merchandise, facility use, and livery that the customer may wish to select.
