Dump Trailer Rental Contract

Terms & Conditions:

The undersigned customer requesting service (including prime contractors and subcontractors), agrees to the following terms and conditions for dump trailer dumpster rental from Fall Line Reliable Services, LLC, DBA Aiken Dumpster Rentals.

Pricing & Payment:

1. Customer agrees to pay the following base fees for the rental of the container which includes 3 days of use and one dump of material.
 - 12 cubic yard - \$285 - 2 tons included
 - 15 cubic yard - \$345 - 2.5 tons included
 - 17 cubic yard - \$375 - 3 tons included
2. Additional days of use will be charged at a rate of \$25 per day.
3. Additional weight of material will be charged at a rate of \$50 per ton.
4. A dump and return or “swap out” will be charged at the same rates as above minus 10% (only the first rental is full price). The 3 day rental period will start over following each subsequent swap out. Dumpsters will not be swapped out on Saturdays, Sundays, or prior to 7:00 am or after 5:00 pm on weekdays.
5. Customer is responsible for any additional fees assessed by the landfill for prohibited items such as those discussed below.
6. Payment for all base fees as well as any known additional rental time will be due prior to dumpster pickup and removal. **Failure or refusal to pay will result in dumping of contents back on the customer's property.** Any additional fees due to overweight, fines for unauthorized materials, or other fees not paid upon pickup are due within 7 days of container pick up.
7. Accounts with additional fees not paid within 7 days will be assessed a late fee of \$25 on the 8th day and again every 30 days thereafter.
8. Payment must be in the form of cash, check, or one of the following electronic payment options: Paypal, Venmo, Cash App. Customers can also be invoiced electronically which provides the option of paying via credit card through the invoice.

Dumpster Use:

1. The following items are strictly PROHIBITED from being placed in the dumpster:

- Liquids of any kind whether contained or not.
- Large appliances.
- Large electronics (such as flat screen TVs or old style tube TVs)
- Extremely heavy material such as rock, asphalt, soil, concrete, bricks, logs or tree stumps.
- Cans, drums or other containers of any kind unless emptied and crushed and incapable of carrying any liquid.
- Substances hazardous to health, toxic or corrosive materials or liquids, such as but not limited to asbestos, liquid paint, anti-freeze, petroleum, lubricants, cleaning solvents, radioactive materials, car batteries, etc..
- Medical waste, biohazard waste, human remains, or animal carcasses or fecal waste of any kind, including but not limited to material soaked with bodily fluids, crime scene clean up materials, syringe needles, medical instruments and other medical waste.
- Propane bottles or any similar containers designed to hold pressurized liquids or gasses
- Any material not listed above but otherwise considered hazardous waste or waste that has known special disposal requirements.

*If any such items above are hidden in the dumpster and Aiken Dumpster Rentals is charged at the dump site, CUSTOMER agrees to pay actual charges and fines. CUSTOMER is responsible for contents of the container during the rental period, and for any charges associated with restricted contents.

2. Items that have special disposal requirements or fees:

- Mattresses (not counting box springs) +\$10 each in Aiken county, +\$25 each outside of Aiken county
- Vehicle tires +\$10 each - must be placed beside the dumpster NOT inside
- Household garbage otherwise known as municipal solid waste +\$75
- Electronics +\$10 each - must be placed beside the dumpster NOT inside
- Shingles - allowed only if loaded to a maximum of half-capacity by volume. Customer is responsible for additional fees for being over weight allowance
- Large appliances such as but not limited to water heaters, refrigerators, freezers, ovens, washers, dryers, HVAC units, etc. (if you need to dispose of these give us a call and we will give you a quote to recycle them properly)

3. Customer shall ensure that all refuse remains within the confines of the dumpster and shall not extend above or outside of the side boards. Every effort shall be made to equally disperse the weight of the refuse within the dumpster. Items extending outside of the dumpster will be removed and left on-site or disposed of for an additional fee.
4. Customer shall be liable for any loss or damage to rented equipment caused by abuse or misuse in excess of reasonable wear and tear.
5. Customer shall not attempt to move the dumpster from its delivered position.
6. Customer shall not attempt to raise/lower the dump bed on the dump trailer or gain access to the dump battery/pump motor box.

Access and Ground Conditions:

1. The Customer will be responsible for the provision of free and suitable access to and from the delivery site (including the removal and reinstatement of local obstructions) and for ensuring suitable ground conditions for delivery, placement and removal of the dumpster. No responsibility will be accepted by Aiken Dumpster Rentals for the damage to any surface on which the dumpster is placed and the customer should therefore take steps to protect surfaces (e.g. paving slabs, walkways, soft ground, turfgrass, sprinkler heads, septic system) before delivery.
2. Dump trailers used by Aiken Dumpster Rentals are considered driveway safe and should not cause damage to concrete or asphalt driveways. However, the customer acknowledges that the possibility of some damage still exists and relieves Aiken Dumpster Rentals of any responsibility, assuming proper use of the dump trailer.
3. The customer shall provide unobstructed access to the premises where the dumpster is located on the agreed upon pick up day or at any time should Aiken Dumpster Rentals deem that the dumpster has been damaged or otherwise misused, filled with unpermitted items, or any other circumstances that exist which are in violation of this agreement.
