**GENERAL PRICE LIST**

These prices are effective as of January 2, 2026  
but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. Consumers have the right to select only the goods and services desired. However, any funeral or cremation arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy an item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the goods and services you selected.

**BASIC SERVICES OF FUNERAL DIRECTOR & STAFF** \$ 2195

The basic service fee is non-declinable and fully explains the services offered by the funeral director. Our fee for the basic services of funeral director and staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation of obituary and posted at our website with photo; coordination with those providing other portions of the funeral, i.e.; cemetery, crematory, vault company and others as required. Also included in this charge are overhead expenses relative to our facility such as sheltering of remains, professional licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, forwarding and receiving of remains.)

**EMBALMING:** \$ 995

Embalming is not required by law, but if chosen, a fee will be charged and an explanation for the reason for embalming will be provided. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**USE OF FACILITIES & STAFF FOR VIEWING/VISITATION** \$ 250 per hour

Our services include set-up of visitation area, display of floral arrangements, supervision of and attendance during the visitation.

**USE OF FACILITIES & STAFF FOR FUNERAL CEREMONY \$ 695**

Our services include coordinating the funeral arrangements, supervision of funeral and staff to attend funeral ceremony.

**USE OF FACILITIES & STAFF FOR FUNERAL CEREMONY WITH A CALLING HOUR PRIOR TO THE SERVICE \$ 795**

**USE OF EQUIPMENT & STAFF FOR CHURCH SERVICE \$ 595**

Our services include coordinating the funeral arrangements, supervision of funeral and staff to attend funeral ceremony.

**USE OF EQUIPMENT & STAFF FOR GRAVESIDE SERVICE \$ 595**

Our services include accompaniment of remains to cemetery, supervision of graveside service with attendant at the service.

**USE OF FACILITIES & STAFF FOR PRIVATE VIEWING (1 HR) \$ 295**

**USE OF FACILITIES & STAFF FOR MEMORIAL GATHERING \$1295**

Our services include coordinating the memorial service arrangements and supervision of the memorial service at one of our funeral homes. 1-3 hours

**USE OF EQUIPMENT & STAFF FOR MEMORIAL SERVICE AT OTHER LOCATION, one attendant \$ 495**

**TRANSFER OF REMAINS TO FUNERAL HOME \$ 450**

Travel within 25 miles beyond this radius is \$3.00 per mile

**HEARSE TO CEMETERY OR CREMATORY \$ 350**

**SERVICE/UTILITY VEHICLE \$ 250**

**LIMOUSINE**, may be hired by a local Limousine service

**CASKETS: \$ 1195 to \$ 9995**

A casket price list detailing the price and description of each casket usually offered by the funeral home will be made available to the consumer for perusal.

**OUTER BURIAL CONTAINERS: Cement Vaults \$ 1695 to \$ 8995**

An outer burial container price list detailing the price and description of each outer burial container usually offered by the funeral home will be made available to the consumer for perusal.

**URNS: \$ 50 to \$ 995**

A complete price list will be provided at the funeral home for caskets, vaults & urns.

**Alternative Container for Direct Cremation \$ 150**

A Burgundy Guest Book, Thank You cards (25), and 50 Prayer Cards are complimentary with a funeral or memorial service, or you may select a box set at \$200

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$ 2995**

This charge includes removal of remains, necessary services of funeral director and staff, embalming, necessary authorizations and local transportation to airport.

**Air Tray for Airline Transportation \$ 295**

**RECEIVING OF REMAINS FROM OTHER FUNERAL HOME \$ 2495**

This charge includes temporary shelter of remains, transportation of remains to cemetery and necessary services of funeral director & staff.

**IMMEDIATE BURIAL** (does not include vault or open/close grave) \$ 2590-3585

The charge for immediate burial includes removal of remains, local transportation to the cemetery, necessary authorizations and basic services of staff. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial.

- a. Immediate burial with casket provided by purchaser \$2890
- b. Immediate burial with blue/taupe cloth covered soft wood casket \$4085  
selected from our funeral home.
- c. Immediate burial with casket selected from our funeral home \$2890  
(in addition to cost of the casket)

**DIRECT CREMATION** \$2545-2695

The charge for a direct cremation includes removal of remains, local transportation to Oyster River Crematory in Lee, NH, necessary authorizations, basic services of the staff and crematory fee. This charge does not include use of facilities and staff for any visitation or ceremony, public or private, prior to the cremation. Cremation may not take place until 48 hours after death, according to NH state law. Alternative containers are available for direct cremation. Alternative containers encase the body and can be made of materials like fiberboard or composition material. The containers we provide are fiberboard boxes.

- a. Direct Cremation with container provided by purchaser \$2545
- b. DIRECT CREMATION with Alternative Container \$2695
- c. Direct Cremation with casket selected from our funeral home. \$2545 (plus cost of casket)

Price includes placing cremains (cremated remains) in urn or keepsake, or in the temporary container. If merchandise brought in, purchased elsewhere, a handling fee of \$10.00 per piece will be assessed.

Charge for a private viewing within 24 hours before cremation \$295  
this private viewing is limited to 10 people and not more than one hour.

No viewing of a deceased person after 24 hours, unless embalming is requested.

Cremated Remains "Cremains" are typically available 5-7 days after your loved one's death, relative to all documentation being completed by the Doctor, ARNP, ADME or Medical Examiner.

**CREMATION OPTIONS:**

- a. Cremation with a viewing hour and/or service with a cloth covered softwood casket, blue or taupe \$6495
- b. Cremation with a memorial gathering or service at our PFH \$3990
- c. Cremation with a graveside service, or memorial service at other place \$3290
- d. Direct Cremation \$2695

**OTHER OPTIONS:**

- Green Burial \$3595  
at a “green” cemetery, in a cloth covered cardboard casket,  
does not include cemetery charge to open and close grave
- Anatomical Donation to a Medical School \$ 995  
for our services rendered

**\*Saturday/Sunday or Holiday funerals or memorial services please add \$300**

Embalming is required for entombment at a cemetery tomb to await spring interment.

Spring interments are planned Monday-Friday between 9am and 2pm and will take place by May 15 of the calendar year, preferably, as soon as possible, upon notice from the cemetery superintendent that the cemetery has opened.

Funerals typically take place between 3-5 days, no later than 7 days.

**TERMS OF PAYMENT:**

One half deposit on account at arrangement conference, with balance due by day of service, receiving of cremains, or no later than 5 days.

We accept cash, check, Visa, Mastercard, Discover and American Express.

A late fee of 1% per month, 12% annual fee, after 30 days for unpaid balance.
