In case of question, the juror's decision will be final. *All work displayed must remain for the duration of the exhibit.* 

Entry Fees – \$25 for up to 2 entries

**Awards** – Ribbons and cash awards will be given for 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> place, plus honorable mention in the show. Throughout the show, the public can vote on People's Choice Award.

#### **Presentation of Entries**

All art works must be delivered ready to display. All artwork to hang, **must have** wire securely attached for hanging in place – recommended wire attached 1/3 distance from top of canvas or frame. **No sawtooth hangers.** Each piece must be identified on back of each piece at bottom, with artist name, address, phone number, title, and price. Artwork that is delivered chipped, cracked, with damaged frames, dirty, or with improper presentation will be disqualified.

#### **Dates to Remember**

March 30 - Registration Form and entry fee must be received by March 30<sup>th</sup>.

Saturday, April 6<sup>th</sup>, 10 to 11am – Hand deliver artwork to *Fuse Box Container Gallery, 8900 Westminster Blvd.* (across from Alamo Theaters). The show will be juried on April 10th. Artists with unaccepted pieces will be called that day and will need to pick up any rejects.

**Friday, April 26**<sup>th</sup> – Reception and Award presentation, 4-7pm.

**Saturday, May 4th – 3 to 5pm –** Take down show and artists pick up artwork. We are not able to store any paintings. All unsold artworks must be picked up by 5pm.
