# 5. Community Issues Tracker

AD led a few questions from the tracker.

Albert Road – ongoing issue with Cloch Court for 15 months. AD along with residents met with IC reps on 13/6/25 with disappointing results. Residents offered sensible solutions, IC advised that 'guidelines' restricted options. Yellow lines will be repainted. Discussion about what 'guidelines' mean involving Stuart McMillan and Lynne Quinn. Leaving as is is dangerous but IC states that *no one has died* which is an unacceptable statement. Many instances of parking changes in town. Stuart McMillan to discuss with residents and we shall action thereafter.

Queens Hotel - Planning accepted with conditions. Make contact with owner.

**Shore St –** This situation has made the community very angry. MP Martin McCluskey and MSP Stuart McMillan have agreed to write to owner seeking resolution. Bowman Rebecchi to be contacted given their quote in the GT article about GCC's campaign. Hamish to write to them.

Ferries – AH notes no updates but will monitor.

**ACTION AH** 

**Gourock Women –** ethical standards did not uphold our complaint, finding there had been no breach of the code of conduct and offered no apology. We shall continue speaking out, supporting our women and ensure a zero tolerance towards what GCC and the community feel to be misogynistic practice.

One way Kirn Drive – awaiting next steps in consultation process.

Petition Powers – The petition was raised with officers at a meeting to discuss Cloch Court. GCC were advised that a petition had not been required, that no action had been progressed by officers following the committee decision to continue to the petition, and that GCC are creating too much work for officers. advised to stop bothering IC! GCC asked officers to progress action and update GCC. No engagement and no communication. To be followed

ACTION AD

**Children's Rights –** we have been advised that it is possible to co-opt a representative young person (16+) onto GCC with voting rights and we will be exploring this with schools, as well as alternative and appropriate ways to ensure children's rights and voice are embedded in all of GCC's work and decision making and in wider context get a young member of the community a role within the GCC. We need to contact all

schools and ensure that their wishes are embedded into out roles as councillors.

#### **ACTION AD**

**Cloch Road –** SMcM noted various campaigns that are short term. Re speeding, are average speed cameras affordable, Police been asked and awaiting feedback.

**Finish the Jobby –** GC is part of Green Tangerine leading the campaign for awareness of dog poo. Funding achieved and action via the schools will happen after Summer break. GCC to offer support as required.

Kiosk - to be added to Tracker

Need follow up on Buses, Wind Farm.
