The organization received contributed professional services of \$94,432 not included in the above program expenses. Services included presenters at the conference, regional workshops and webinars.

ABACC provides a resource forum based on topics of interest to member institutions. Tools and reading materials address the variety of areas for which a typical business officer is responsible.
