### Clinard Appealing Transfer to Adult Court

Jason Clinard, the Stewart County teenager who shot and killed bus driver Joyce Gregory in Cumberland City, in 2005, has petitioned the US District Court of Middle TN several times in recent months, leading up to his transfer hearing yesterday. In a previous edition of the Standard, we reported DA Ray Crouch, Jr. as saying, “The Sixth Circuit Court of Appeals held, ‘because there is a reasonable probability that Clinard would not have been transferred to adult court absent his counsel’s ineffective assistance, Clinard is entitled to a new transfer hearing.’” Crouch added, “If adequate grounds are found to transfer Clinard to adult court, this will presumably conclude the appellate process and the conviction and sentence will stand. However, if the Federal District Court determines that Clinard should not be transferred, the convictions could be set aside.”

All proceedings have gone before Magistrate Judge Brown. According to records we’ve received from the Court, on Feb. 8 of this year, Clinard “requested the Court deny the transfer petition since granting it would necessarily subject him to unconstitutional sentence.” On Feb. 25, the “Respondent’s motion for judicial notice and to limit the scope of the hearing to evidence available on or before August 2, 2005,” was granted. Several court dates followed, and on March 8, Clinard petitioned the Court with a list of potential witnesses including: Dr. Duncan Currey, **Continued on Page 4**

Will Taylor, Lifeline Coordinator for Region 5 North, with the TN Dept. of Mental Health and Substance Abuse spoke in Loyd’s place. ### Nellie Settle Only Remaining Election Commissioner

After three commissioners resigned in two weeks, just ahead of the end of their two year terms, the new Stewart County Election Commission met, Tuesday, April 2, at 4:30 pm. There were all new members except for one, long time Democrat Commissioner, Nellie Settle remained a Commissioner. They met to select a chairman and go over organizational procedures for new commissioners. Three Republican replacements were appointed by the State Election Commission, Monday, April 1, after being recommended by District 75 State Rep., Bruce Griffey. The three, who were expected to be placed on the commission, Tim Borens, Robert Girndt and Carol Lovin were all sworn in at the meeting. Lovin was named Chairman.

One surprise, long time Stewart Co. resident, Jane Bagwell, was named by the State Election Commission to replace the Democrat Commissioner who resigned March 26, hours before a called meeting. Bagwell was at the meeting but couldn’t vote yet because she had not been made official. Settle is considered to be on hold over status and said she would wait to be sworn in with Bagwell, Settle was also elected secretary. The majority party names the chair and the minority party names the secretary. Each Election Commissioner will serve a two year term, ending March 30, 2021.

The meeting started with Settle and Election Administrator Daniel Perigo explaining some procedures to new members. Perigo said, “The way it will work starting out, the eldest person here will run the **Continued on Page 9**

### Inmate Designs New Stewart Co. Sheriff’s Patch

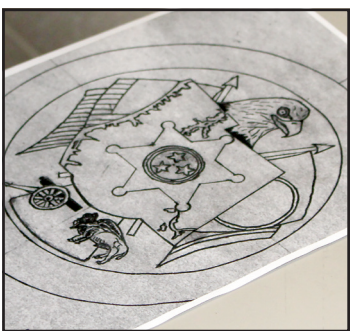

Inmate Thomas Craig Welker, drew the design to be used for new Stewart Co. Sheriff’s Deputy uniform patches. Sheriff Frankie Gray said he drew a very rough layout for Welker to follow. Gray said, “I just drew a circle from a CD with a circle from a coffee cup inside of that, and a couple of stick figures, flags and he did everything else. Someone told me you need to see if Craig can draw it for you. I wanted the river in there the way he drew it but they said that was too much detail. The company making the patches changed just a couple of things and put color to it but mainly used his design. We should get them in a couple of weeks and be placing them on uniforms.” The company, SymbolArts, out of Utah,

Copyrighted the design so we couldn’t publish the final design without permission. Welker said, “I used the Stewart County map from the front of the Standard, and used some other things to trace shapes, and I drew the cannon and the eagle.” Welker had been in the Stewart Co. jail since Nov. 27, 2018, for a Violation of Order of Protection.

# Clinard Update

Dr. William Bernet, and former teachers: Myles Holliday, Rebecca Grasty and Carrie Pellum-Howell. Also, Clinard requested school records, therapy notes, psychiatric evaluations and other exhibits be made available. On March 22, Respondent Randy Lee, Warden, filed a first motion “in limine” to exclude witnesses. A motion “in limine” is a motion, discussed outside the presence of the jury, to request that certain testimony be excluded. Lee asked Clinard’s lay witnesses (Holliday, Grasty & Pellum-Howell) be excluded from the transfer hearing, stating Federal Rules of Evidence, “Petitioner should be precluded from proffering (offering/suggesting) witnesses who can only offer irrelevant, unreliable and inadmissible testimony.” Background info in that hearing included, “On March 2, 2005, Jason Clinard (“Petitioner”) shot his school bus driver three times with a .45 caliber handgun. He was fourteen years old. The day before the murder, the victim had reported Petitioner to school authorities for ‘dipping snuff on the bus.’”

In the respondent’s second motion in limine (filed the same day), it was requested that certain evidence be excluded from Clinard’s transfer hearing including, “therapy notes of Roger Batson (a licensed professional counselor who provided therapy to Clinard’s family after his incarceration) and an affidavit of Kathy A. Smith (an English teacher at the time of the murder).” Clinard’s own motion in limine filed the same day, requested the exclusion of a report by Dr. Kimberly Stalford, psychiatrist, specifying, “her testimony should be based solely on information available to her by the time of the juvenile transfer hearing.” According to court documents, “At the hearing on August 2, 2005, Dr. Stalford gave testimony that amounted to a harsh assessment of Clinard. Her bottom line was that, in her view, Clinard’s conscience was just plain defective and he was incorrigible. During that hearing, when the State had just one witness left to call (TBI Agent Joe Craig), Clinard’s lawyer agreed to a transfer to adult court.” Clinard also requested exclusion of testimony by Judge Andy Brigham and Dr. Kimberly Brown (a professor of psychiatry at Vanderbilt University). With regard to Brigham, the motion from Clinard reads, “Judge Brigham, the Stewart Co. Juvenile Court Judge, testified at Clinard’s post-conviction hearing to establish certain historical facts,

including (that he) that defense counsel gave virtually no reason for agreeing to transfer to adult court, that he did not have to decide whether to transfer Clinard due to defense counsel’s agreement, and that, when defense counsel so agreed, he (Judge Brigham) still had not reached a decision regarding transfer.” Clinard asked that Dr. Brown not testify as an expert witness, but regarding, “her personal knowledge of the state’s resources available in 2005 to house and treat juvenile offenders.”

In Clinard’s response to the State’s motion, filed March 29, Document 79 states, “At the juvenile transfer hearing of August 2, 2005, the State’s expert testified essentially that, in light of Clinard’s putative ‘long-standing history of acting out and violent behavior,’ she concluded that the recent shooting incident showed that his ‘conscience’ was simply broken and so he could not be rehabilitated.” Clinard requested three teachers speak to his character and behavior, “in the months leading up to the incident”. Finally, in response in opposition to Clinard’s motion to exclude exhibits and witnesses, (Stalford, Brigham and Dr. Brown) filed March 29, documents state, “There is no dispute that the issue before this court requires expert assistance to aid in the understanding of the question presented: namely whether the ‘interests of the community require[d] that [Petitioner] be put under legal restraint or discipline,’ pursuant to Tenn. Code Ann. § 37-1-134(a) (4)(C)(2005).” Clinard asked Dr. Stalford’s report not be included in testimony, as document 80 states, “Petitioner solely complains that Dr. Stalford’s report relied on ‘inherently unreliable’ information when she interviewed the petitioner because the petitioner viewed her ‘as someone who would treat him harshly or unfairly.’” Additionally, Brigham’s testimony should be considered, “both admissible and advantageous,” based on a similar case; and Dr. Brown’s testimony was viable. “Her extensive experience in making recommendations to DCS about youth placement since at least 2002 gives her credible insight...,” the document states. The latest order from the court, dated April 3, 2019, denied the motion from the respondent, to exclude witnesses, stating “Without any idea what these three witnesses are to testify about even though this motion has not been opposed it is denied.”

We will follow up on the results of Clinard’s transfer hearing in a future edition of the Standard.

### Education Savings Accounts

You may have seen Rep. Griffey ask for input on HB 0939 reference ESA’s (Education Savings Accounts) that would be available in other parts of the state (urban areas) but not here. I consider Bruce a friend, I voted for him and can tell you he is trying hard in our RINO (Republicans in Name Only) infested state legislature to keep his campaign promises without any support from the leadership according to what some friends up there have told me. Having said that, there is more to this bill than just continuing to spend more on chronically failing urban districts by opening accounts for parents of the kids that qualify to receive over \$7,000 a year to put their kid in a private or charter school!

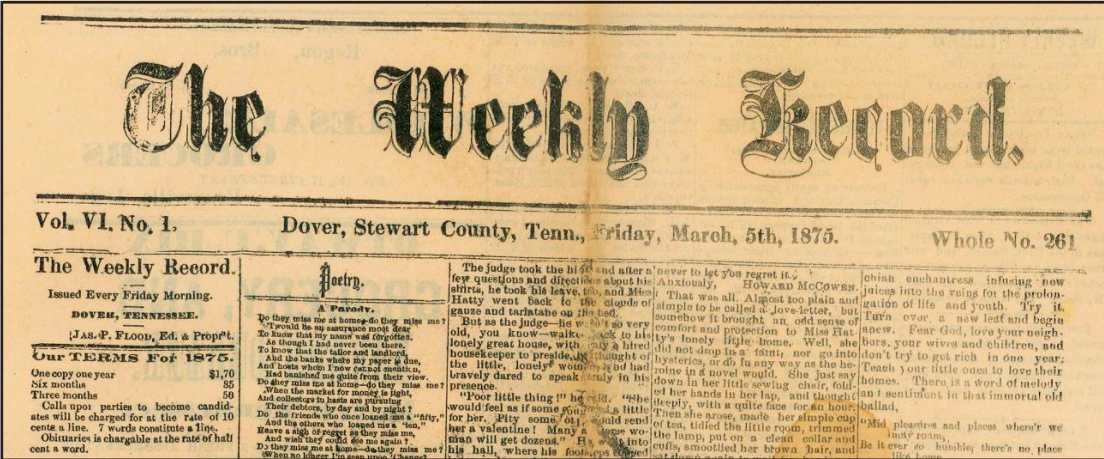

And to make it worse, after the kid turns 18, he or she can (by providing one fake document) take over that account and use it for college until they are 22 years old! This bill would also enable all religious schools that are certified by the state accrediting agencies to participate, which means the 4-5 Islamic schools we currently have in the state, can take part. # Health Council Discusses Vital Signs

The SC Health Council (SCHC) met recently for the third session of the County Health Assessment (CHA). Three “vital signs” were chosen in an earlier meeting: third grade reading levels, youth tobacco use, and youth obesity/physical activity. Once identified, strategies to collect data were discussed in this session. Additional specific information about each indicator was discussed, as well finding one or more point persons for perspective, primary data collection methods (whether a listening session, key informant interview or survey), timelines to garner information, and the person/entity responsible for data collection were all covered.

With regard to third grade reading levels, SC Health Director Karen Anderson handed out information stating, “Even though education is listed as a strength, Stewart Co. is below the TN average for mastery of 3rd grade reading level.” The school system now has a Response to Intervention program in the schools and children are now reading at the Kindergarten level. SC Director of

Schools Leta Joiner said, “If your reading level goes up, your math level goes up.” Further info will come from test scores and Accelerated Reading (AR) data.

Claudia Barajas, Vanderbilt Ingram Cancer Center, brought cancer statistics for the county. Top causes for cancer death rates of Stewart Countians were: (1) lung cancer, (2) female breast cancer, and (3) prostate cancer. These rates tie in to youth tobacco use. SC Alliance for Substance Abuse Prevention (SC ASAP) Coordinator, Melissa Fields, will bring a youth tobacco use survey from 8th, 10th & 12th graders regarding 30 day use and age of first onset. As JUULing (vaping) use is on the rise, Fields is working with Elaine Jackson and Coordinated School Health (CSH), to curb youth vaping. Joiner said vaping is on the rise and more prevalent at the middle school. SCHS currently has a program for ISS students who have been caught using tobacco or vaping. Barajas added there are higher doses of nicotine while vaping. She attended a workshop at Vanderbilt recently, where government proposals

included raising the legal age for tobacco sales to 21 and stricter laws for those who sell to minors. The schools will create a survey to garner youth tobacco use from teachers. Poll results and discipline reports will be used to determine tobacco use.

Youth obesity/physical activity levels information can come from PE teachers, BMI stats from Jackson, listening sessions with WIC recipients at the Health Dept., Family Nutrition Education Program (FNEP), and other programs. Joiner said, “Diet needs to be coupled with activity. Taking recess away as a punishment is not a good idea. Kids need activity.” Annette Cole, Family Nutrition Director said, “We are a food desert here. We have one grocery store and the rest are convenience marts.” Cole is working on a grant to bring the Farmer’s Market back, so residents will have more access to fresh fruits and vegetables. Several program updates were given, and the meeting was adjourned. The next meeting is scheduled for April 24 at noon at the SC Community Medical Center.

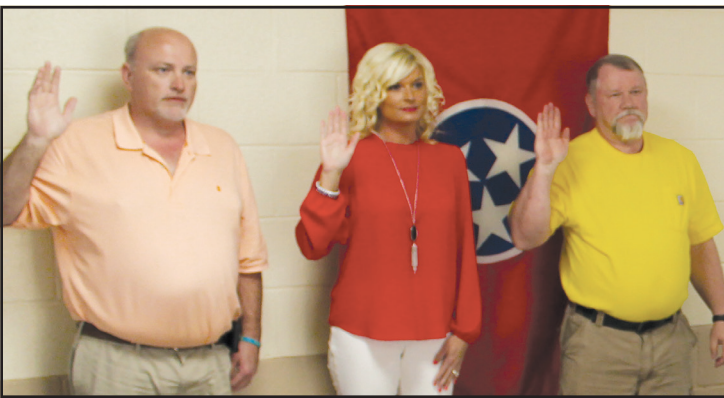

meeting.” It was determined Settle was the eldest member. Perigo let Settle know, “You will open us up and ask for nominations for chair, since Jane has not been made official, you will be the secretary for now.” After Borens, Girndt and Lovin were sworn in by Perigo, the meeting was called to order by Settle. They went through the Agenda, Lovin asked for a motion on the March 12 meeting minutes and they were approved. She then said, “Is there a motion to certify the early voting and election day voting machines for the April 23, 2019 Election?” Girndt made the motion, Settle seconded, Perigo showed members the tech certifications done on the machines and explained the process on certifying the machines. Lovin called for a vote, and the motion was approved. Keys for ballot boxes were handed out to one Democratic member and one Republican member. Perigo said, “They just can’t be here, that’s the biggest thing, they can’t be in this office.”

Next was approval of the official list of poll workers, Perigo explained they try to put two Republicans and two Democrats at each polling place. Perigo also said

they are trying to get Senior SCHS Students to work with the regular workers, one at each precinct. He said there would be at least three adults with one student. He also said, “They have to be 17 years old to work, if they are 18, they have to be registered to vote.” The list of workers was approved. They then approved Voter Registration applications. Lovin asked, “So, these people were registered to vote Jan.-March of this year? Perigo explained, “Yes. There were 122 registrations from Jan.-March, you have to check 10%. You will inspect them to make sure a name is there and a legal address, a PO Box is not a legal address. Also, you will make sure they answered all the questions, date of birth, place of birth, Citizenship of the US, etc.” Lovin asked about how they verify addresses. Perigo answered, “One of the ways, if it comes from the Dept. of Motor Vehicles, it’s automatically verified. That’s the easiest way. The other way is we send out a verification card, they have to pick that up out of their mailbox and bring it in.”

There were some questions about Election Day and how that would work, Perigo explained once the absentee counting board starts, no one can leave and no information can go out. Lovin asked if there had ever been any issues in the past and Settle said there never had but told a funny

story from a while back. Settle said, “We’ve had some times in the past, the machines were so obsolete, we couldn’t get parts for them. It got to where the voting part would only show half the X. altering substances since 10/31/13. I found recovery through the legal system. I’m from a little town similar to Stewart Co. We didn’t really have many resources. I didn’t even know I needed to recover, the judge said, you can go back to prison or go to treatment.” He talked about how he was first introduced to alcohol at age 11 and the effects of drugs on the pre-frontal cortex of the brain. “What happened at that moment, the effect that hit me was a feeling of being a part of something. I ran with that for right at 20 years. What happens is all of our instincts turn to being able to go forward in life and to belong, it actually becomes part of our nature, our will to survive. Substance abuse becomes a priority and rules their life. The pathways that connect to our pre-frontal cortex becomes hijacked. What I mean by that, is the chemical firing is not going through and rational judgement is lost. It takes a minimum of 90 days to start getting some action back to our pre-frontal cortex. A minimum of two years to get full function back to our brain after an addiction. I challenge everybody tonight to open your minds up and be that support system for someone addicted to substances.”

The state representatives had much statistical information and power points

proving the scope of this epidemic across the state, but it’s the families who are personally impacted. Fields came up next and introduced actual people living in Stewart Co. with a personal testimony of how they overcame. Fields thanked the speakers from the state and said to the crowd, “We also need to hear from our own folks here in Stewart Co., people who have had addiction in their life, people who are raising their grandchildren. Someone who is in recovery from addiction. Just the reality of addiction.” Fields brought up the theme of the seminar, End the Stigma. “I continually see people suffering from the stigma of addiction, suicide and mental health disorders.” She said in Stewart Co. there were 42 people who overdosed but didn’t die in 2018. “In Stewart Co. we had 18,594 Opioid prescriptions written in our county. Is it excessive? Absolutely. I truly believe God uses broken people like you and me to fix broken people like you and me and we have to support one another.” She then introduced two families who have dealt with suicide and how it’s not something people really talk about. Robin Wright and Kim Cottrell Earhart with her son Dylan, came to the podium. Wright talked about the extremely difficult loss of her 17 year old son to suicide in 2011. She said, “He hurt a lot more than we knew. The night before we talked about his future, everything looked great. If you have those thoughts, or know anybody, please take

them seriously, don’t dismiss it.” Earhart talked about losing her husband to suicide and mentioned how everything seemed normal. We didn’t have any signs, he was happy as can be. He never would have done this to me and the kids in his right mind.” They never saw it coming and have had to work through many emotions of guilt, depression and more but mainly hoped they could help someone else not have to go through the same ordeal.

There were other speakers who were very open about dealing with many different mental issues. One speaker said they learned how to put on a happy face in public but dealt with alcoholism at home. Others had been addicted to drugs and are in recovery. A grandmother got up and talked about raising her grandkids because of her son’s drug addiction. She also talked about the high statistics of child abuse in our county, children placed in state custody, divorces and many more social ills confronting our community. In some of the most personal testimony of the night, a woman courageously got up and talked about her mostly drug and alcohol filled life. She said, “With God’s beautiful Grace I have been set free. God led me straight to the sponsor I have now. I was in and out of jail, would be good for a while and then get back into the drug life.

I did this most of my life. My high school years were a blur. I’m over 11 months clean.” She wanted to thank God and her Celebrate Recovery family.

The main idea of the night was to get over any stigma, which means by definition, a mark of disgrace associated with a particular circumstance, quality, or person. Remember, the only way to deal with a problem, any problem, is to confront it head on with help and support from those around you and leaning on the only One you can trust, the Lord Jesus Christ, also a theme of the speakers in recovery. One young girl attending the event, Ashleigh Walton, said she was so excited to be there. Walton said, “I was so excited about being at the substance abuse and suicide prevention seminar because I applied to be a first responder in Indian Mound. I’m already CPR, defibrillator and first aid certified, but most of all I wanted to be trained in any situation I could possibly encounter on any given day to save the life of someone’s father, mother, son, daughter, etc. Suicide and substance abuse just hits way too close to home for me and I wanted to be further educated and trained about it all so I could be a better asset to my community and I’m so blessed to have been able to learn all of this. It was a wonderful seminar!”

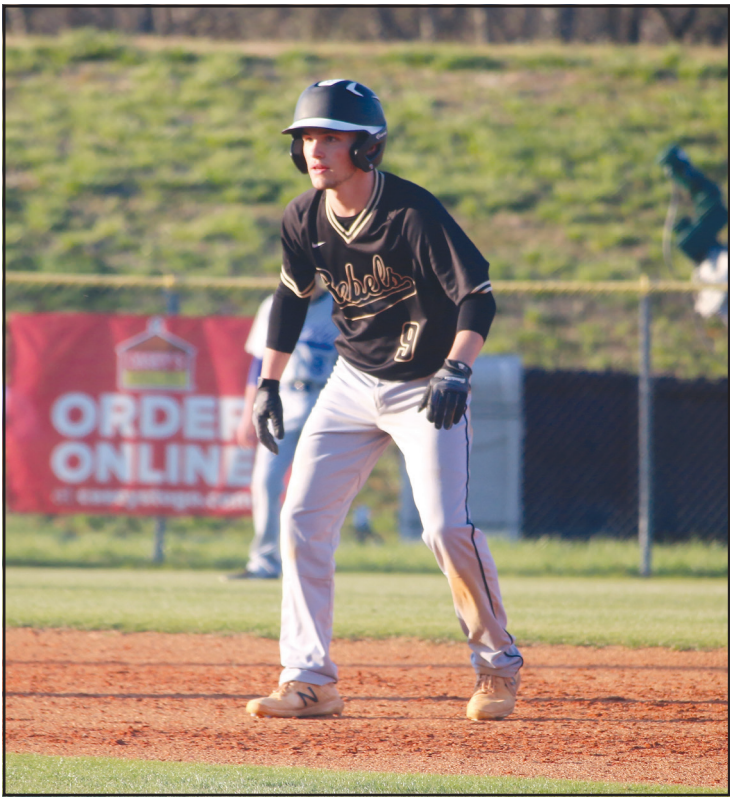

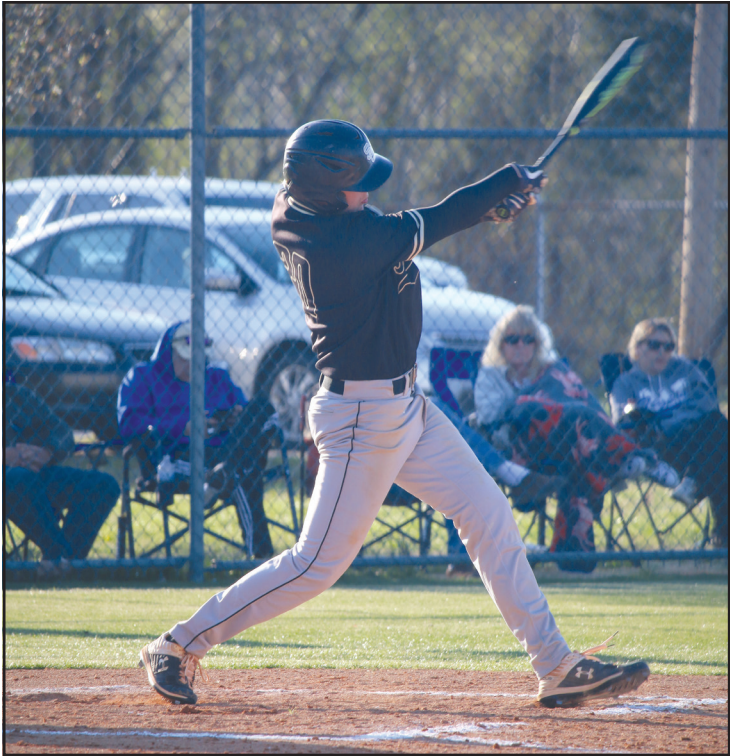

# TWRA Urges Public to Leave Displaced Wildlife Alone

The Tennessee Wildlife Resources Agency (TWRA) is urging the public to leave wildlife alone which appear to be abandoned. Recent flooding in various areas of the state has displaced some wildlife which has resulted in an influx of calls to the TWRA and wildlife rehabilitators across the state.

Each year, especially in the spring and the early summer, Tennesseans encounter wildlife, appearing to be orphaned, sick, or injured. The TWRA urges the

public to leave wildlife alone. In cases with young wildlife where they appear to be lost or abandoned, they have been placed in the location by the parent or parents to keep them safe from predators while the parents are nearby feeding or collecting food for the young. In the case of animals apparently stressed by an injury, a permitted rehabilitator trained and experienced in caring for the animal or bird, may be the best option. However, more often than not, wildlife should be respected and left alone.

# More Non-Profits Explain Needs to Committee

The Non-Profit committee met Monday, April 1, at the Stewart Co. Visitors Center to continue hearing from organizations and their requests for 2019-20. First on the agenda was Boy Scout Troop 501 followed by Cub Scout Pack 501, who both requested the same amount as last year of \$1,200. Both of these organizations work closely together, the only difference being age. The biggest expense is sending the kids to summer camp. Mayor Robin Brandon spoke to the Boy Scout representatives and stated, “Not only do they do a lot of things in the community as far as clean up, they’re additionally volunteering to come and help us clean up at Grays Landing.” The Good Samaritans also requested the same amount as last year of \$4,000. Carol Suiter, Vice President of Good Samaritans explained how they’re there to meet the needs of our county. Brandon stated, “It does show you have an ending balance of \$57,281, do you ever get down towards zero with that?” Suiter answered, “Well we just paid off that building we’re in, \$27,000, so that brought our balance down quite a bit.”

Next, the Stewart Co. Historical Society, represented by Lawrence Saunders and Kim Schmidt requested \$500 more than last year. \$2,600 is the total requested for 2019-20. Saunders mentioned Schmidt would now be taking his position as treasurer. Brandon stated, “The preservation of our historical records is one of the most important things we can do for future generations of Stewart Co.” Bonnie Lill, President of the SC Adult Literacy Council, requested the same amount as last year of \$1,500. Lill said, “One thing I’ve always loved about this county is you don’t have to be rich or powerful for somebody to help you out...We have a good success rate for our students.” Lill explained how most of their budget goes to test fees. SC Senior Citizen Center, represented by Sandra Foust, requested \$500 more than last year which was \$15,000. Foust explained how she needed the extra \$500 for Automated External Defibrillators (AED), which is a battery-operated device used to administer an electric shock through the chest wall to the heart. Foust stated, “They run about

\$800-1,000, I will fundraise to make up the difference.” Mayor Brandon then asked if the Senior Citizens were happy with the Mid-Cumberland transportation service, Foust said she believed they were. Brandon mentioned he had heard some complaints.

Hands & Feet Ministries represented by Benjamin and Marcy Robertson, was one of the two new Non-Profit organizations for 2019-20, who requested \$10,000. Ben Robertson stated, “We started out as a Celebrate Recovery and we saw very quick that was not all that was needed... We started seeing people come through who really wanted to do better so we decided to open the thrift store Second Chance. We did this to try and fund different services so we could provide for people who couldn’t provide for themselves.” Robertson mentioned the thrift store recently has been turned into a coffee shop to promote positive support. Brandon mentioned this organization and the rehab fund cannot work without one another. Marcy explained how they have been working closely with the new rehab fund. Tammy Gray and Mike Winstead represented the Non-Profit, SC Rehab Fund. Gray stated, “We’ve been around since May 31... a rehab can run anywhere from \$7,000 up to \$60-80,000. Studies show when an addict is ready for rehab, they have less than 12 hours to get in before they change their mind. We have to know the person is sincere, and only take them if they’re willing to go six to eight months.” This organization requested \$10,000 as well.

SC Fire Rescue was last on the agenda, requesting \$88,000. Last year, they received \$110,000. Chuck Gant, Chairman of SC Fire Rescue, stated, “We take a lot of money to keep our operation running... We have operational control over nine fire stations.” Gant explained how busy they are and explained why they asked for less money this year, which was due to getting over a financial hump. Brandon stated, “One of the best working relationships I’ve had since I came into office is with Gant and Deputy Chief Ethan Luffman.” The meeting was adjourned and will meet again Thursday April 11, 6:30 pm at the Visitors Center.
