The goods and services shown in this folder are those we can provide to our customers. You may choose only those items you desire. Any funeral arrangements you select, however, will include a charge for our basic services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

If you choose a funeral service where a rental casket is provided, the casket used for the funeral services may have been used in a previous funeral service. If the casket has been used in a previous funeral service, the interior lining has either been replaced or thoroughly cleaned.

PROFESSIONAL SERVICES

SERVICES OF FUNERAL DIRECTOR & STAFF. \$3,795

Our basic professional service charge INCLUDES but is not limited to ▪ Consulting with the family and clergy ▪ Completion and filing of notices, legal certificates and permits ▪ After Care Services and ▪ coordinating with those providing other portions of the funeral.

The fee for our basic services, which includes overhead, will be added to the total cost of the funeral arrangements you select. This fee is already included in the charges for direct cremations, immediate burials, and forwarding or receiving of remains.

EMBALMING \$685

Except in certain special cases, embalming is not required by law.* Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial or when refrigeration or use of dry ice is available.

* Minnesota law requires embalming only in four conditions. These conditions are fully explained in 149A.91m subd.3. (A copy of these conditions can be obtained from your Director.)

OTHER PREPARATION OF THE BODY. \$250

INCLUDES: Cosmetics, dressing, care and placement in the casket.

DIRECT CREMATION from \$3,295 to \$15,395

This Service Charge is for a direct cremation WITHOUT any rites or ceremony. There is no membership or registration fee for our cremation services.

INCLUDES ▪ Transferring deceased from place of death within a 30-mile radius ▪ Completion and filing of legal certificates and permits.

Minnesota law does not require you to purchase a casket for cremation. If you want to arrange a direct cremation, you can use a cremation container. A cremation container is a combustible closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard and into which a dead human body is placed prior to insertion into a cremation chamber for cremation. Those we offer are the cardboard and wood box.
