The League of Women Voters of Houston (LWV Houston) is seeking a strategic, creative, and mission-driven **Communications & Civic Education Manager** to lead our organization's external communications and digital engagement. This full-time role is ideal for a skilled communicator who is passionate about voting rights, civic education, and community impact.

The Communications & Civic Education Manager reports to the Executive Director and works collaboratively with staff, board members, and volunteers to drive civic engagement efforts in Greater Houston.

Social Media & Digital Engagement

- Develop and implement a content calendar for all social platforms, with a focus on growth and engagement on LinkedIn and Instagram
- Create original content including graphics, copy, videos, and stories tailored to each platform
- Monitor analytics and trends to optimize reach and impact

Graphic Design & Brand Communications

- Design branded outreach materials (flyers, event graphics, digital ads, etc.)
- Maintain visual consistency across all public-facing materials

DETAILS

The position is an exempt salaried position and is not eligible for pay over 40 hours worked in a week. It is full-time with a flexible, hybrid (office and remote) schedule. Occasional evening and weekend work may be required. Lifting of at least 20 pounds and standing for several hours at a time may be required for events.

Salary

The salary range for this position is \$55,000 to \$60,000 with employer paid health benefits, 401k match, paid vacation, and holiday and office closures.
