Treasurers Report : Motion by L Williams and 2nd by M Bortle to approve the Treasurers Report as presented. Roll Call – Ayes – L Williams, R Reid, M Bortle and E Scott. Motion Carried.

Correspondence : We received an application and permit request from ACD / the Metro Act to allow access to data lines for work. Check received for \$500.
