The Warrick County Board of Finance met in Regular Session.

Auditor Michael Dietsch, Chief Deputy Auditor Barbi Shelton, and Recording Secretary Kristine Georges attended the meeting and recorded the minutes.

Commissioner Terry Phillippe called the meeting to order at 10:30 AM.

**ROLL CALL**

**REVIEW OF 2024 FINANCIAL INVESTMENTS, BANKS AND INTEREST REPORT BY TREASURER**

Ms. Heilman presented the 2024 Financials. The County made \$5,100,000.00 in interest. That makes it the best year so far going back twenty years. They are thankful to the banking partners with United Federal having the biggest interest rate right now at 5%. All of this went to General Funds. The only thing that was not on the report were the CD investments. They mature next year. She reviewed some of the other interest earned and what all has been rolled over into new investments. Some of the interest rates have backed down, but even the lowest is sitting at the 3.5% range, so still good.

Commissioner Phillippe asked where the interest sits in the General Fund. Ms. Heilman said it is receipted into the General Fund. They then discussed some of the bonds. There was continued discussion on who would decide how the money gets spent, Council or Commissioners.


