II. ROLL CALL.

A Quorum was confirmed with the following members in attendance:

No recorded absentees. All members were present.

III. CALL TO ORDER.

The meeting was called to order by Election Board President, Paul Rudolph at 3:05 PM

IV. APPROVAL OF PRIOR MEETING MINUTES

The minutes from the November 14, 2024 meeting were approved as presented with 2 yes votes; 0 no votes; and 1 abstention (Michael Wilson)

A signature page was passed around for signatures.

V. OLD BUSINESS/ MEETING AGENDA

1) Review election process of 11/24; discuss areas for improvement

Paul tabled this item until later in the meeting.

2) Preliminary discussion of 2026/2028 resources needed

Paul tabled this item until later in the meeting.

3) Update on campaign finance reports (CFA-4) being filed.

There was much discussion about the list of candidates who were late filing their finance reports. Nancy Woolsey said she thought we should fine the candidates a late fine based on the state recommendation. All candidates were notified by Angie Childress from the Election Office on January 9th of the deadline. Paul had spoken to Jed Hudson about the filing deadline. April

Edwards said she would reach out to Amy Miskimen to help her bring her campaign finances up to date.

After much discussion from board it was recommended that we should follow the guidelines from the state. The board voted as follows: Mike and Amy – Aye; Paul - Nay

Here is a listing of the candidates who had delinquent filings and the fines:

Paul will draft a letter to inform the candidates of the imposed fine.

Mike suggested that we send a certified letter to Jed Hudson and Amy Miskimen from the board regarding their non-filings and unpaid fines. Paul will draft a letter to Amy and Jed. Both letters will be sent to Mike and Nancy for review before they are sent by certified mail to each person.

- 1) (Agenda item #1 revisited) Paul invited comments and opinions from the gallery.
 - a. Don Julian, who worked the 104 Local Voting location, said all things went well. It was positive thing that they had more voting machines. There was confusion about provision voting ballots. He would recommend an increase in training for the judges regarding provisional ballots.
 - b. Cindy Warren would like to see training to be offered more than one day. She would also like to see more specific training for the judge level.
 - c. Danielle Hudson would rather see hand paper ballots instead of Electronic Ballots
 - d. Paul confirmed that it would be helpful to have increased training from Microvote. Perhaps we could videotape the Microvote the training and use it ad hoc for training later. Also, we need to make sure that new workers have the W2 paperwork completed.
 - e. Nancy made notes during the election process about Absentee Ballots. The three items on her list to “drill down” on are: Poll worker training; Absentee Ballots; and Absentee Board. She had concerns about non-employee vehicles transporting voting machines. Nancy thinks that there should be two early voting locations in Newburgh. Some early voting statistics from Greg Tuck and not confirmed by the board are as follows:
 - i. Primary (96 hours) Lynnville Voting location had 0 votes cast
 - ii. General (98 hours) Lynnville voting location had 156 votes cast
 - iii. General (98 hours) Newburgh voting location had 1000 votes castShe suggests finding another early voting location for the Newburgh area. Paul suggested maybe move the Lynnville location to a new east of Bell Road area of Newburgh.
 - f. Mike said he would reach out the Ohio Township Trustee to see if they are willing to host the early voting and primary/general election voting for the next election(s).
 - g. Mike asked Don Julian if their voting place had enough poll pads. Don said they were fine.
 - h. Paul thinks it would be a good idea to have FAQ sheets for the poll workers and judges. This might cut down on inconsistent information being disseminated and less calls back to the Election Office.
2. (Agenda item # 2 revisited)

a) Nancy Bennett suggested creating poll worker check lists to make sure all pertinent information is captured to ensure prompt and accurate processing of their payments for working. Nancy Bennett will work on developing those check lists.

4. Chandler sign issue/discussion

a) Nancy Woolsey and Paul Rudolph thought the Chandler sign issue was resolved. They recommended that the candidates, Sarah Eller and Brittany Daugherty, who had not displayed the proper disclaimers on some of the signs get a letter with a one-time warning of noncompliance and notice that a fine will be assessed if they run again in the future with similar issues.

VI. NEW BUSINESS.

The board had no new business. Paul asked for comments from the Gallery.

- 1) Don Julian asked if the minutes could be viewed online. Mike said we will work on that accessibility. Paul also thought it would be a good idea to post the list of FAQ online for the public.
- 2) Tom Fite asked for a copy of the election analysis. Paul will email it to him.

VI. OTHER ITEMS.

- 1) Paul asked if the board minutes could be available within ten days after the meeting. It was determined that the Clerk's office would try to make that happen.

VII. ADJOURNMENT.

Motion was made by Michael Wilson to adjourn the meeting. The motion was seconded by Nancy Woolsey. The motion carried 3 – 0.
