Approval of Meeting Minutes

Meeting Minutes from December 2025 were approved.

Old Business

Software Updates

Ms. April Hicks informs the Board that she composed a brief of the IWORQ Software and now is waiting for the cost agreements between the departments that will be utilizing the software.

Health Board Vacant Seat

Mrs. Leigh Ann Holder explains that the Board is still currently seeking applicants to fill the vacant seat.

Community Medic Program

Dr. Kahre explains that a contract has been sent to Ascension for their review and an appropriation and advertisement is set for the February County Council meeting. The Health Board's approval of the federal grant funds received by the Health Department in 2023 is necessary for the Council to approve this request. Motion passed for legal to look into what the expired grant funds can be used for. Motion passed for the Board to, subject to legal, endorse the appropriation of the funds for this program.

Intern Opportunity

Ms. April Hicks explains that applicants from the University of Evansville have reached out for the opportunity to intern with the WCHD and documentation has been sent to legal for review.

New Business

Budget Review

Ms. Hicks explains that she has provided the Board with copies of the 2025 and 2026 HFI Budgets and provides the Board with a breakdown of how the 2025 funds were spent. 63.32% of the 2025 HFI funds were spent in the year 2025.

KPI Tracker

Ms. Hicks explains that the Health Department is meeting their KPIs and will continue to do so moving forward. Dr. Weaver is visiting in February.

Schedule of the Health Board Meetings for 2026

The Health Board decided that they will schedule 2026 meetings to occur on the second Wednesday of every month at 3:30 pm. Motion passed to approve the meeting schedule.

Staff Reports

Health Officer-Dr. Kahre

Dr. Kahre explains that she has reached out to the Prosecutor's office to provide funding for the Child Fatality Review Team. Warrick County Coroner, Alyssa Enright, explains to the Board the importance of finding funding for the review team. By Indiana Code, the Prosecutor's office is in charge of establishing the review team. Legal agrees to send an email to the Prosecutor to get this process implemented.

Dr. Kahre explains that one goal for the year is to implement STD/STI testing. Another goal is to have an event at the high schools to promote safe driving and safe sex practices. Dr. Kahre explains she wants to work towards putting in ordinances for county wide AED and Stop the Bleed kits to be available in public spaces.

Sarah Godshall and Deborah Sabla were not able to be present. April Hicks reports on their behalf. In December, nurses continued offering vaccine and TB skin testing. One home visit for vaccines was scheduled. Flu and vaccine clinic was scheduled to be held at Impact Ministries on December 8, 2025 but was rescheduled due to illness with staff and concerns spreading illness. This is rescheduled for February 2026. One home visit for lead follow up testing was conducted. They have begun planning for school clinics for incoming 6th graders and 12 graders to be completed in Spring. We will reach out to Dr. Lambert with the school corporation about flyer distribution.

Client Relations/Outreach- Angelina Pribble
