FREQUENTLY ASKED QUESTIONS

How do your costs compare to area funeral homes?

We would be happy to send you a general price list of our services. You can email heckartfh@gmail.com or call 660-826-1750. Our prices are extremely affordable both on the service end and merchandise end. You will likely find us much more affordable than local funeral providers.

What do we do when a death occurs?

If the death occurs in a facility, let the staff know you would like to use Heckart Funeral Home and they will call us at 660-826-1750.

If the death occurs at home and the patient is under hospice care, you call the hospice nurse and they will notify us of the death, upon your request. If the death occurs at home and hospice is not involved, you will need to call 911. Let the medics know that you plan to use Heckart Funeral Home and they will take care of notifying us. No matter what the time of day, we will come as soon as we get the notification.

Where do your cremations take place?

Heckart Funeral Home has an on site crematory with a specially trained staff to operate the crematory. Your loved one does not leave the funeral home's care when you choose cremation.

If we do not desire to come to the funeral home, will you come and meet with us at our home?

Absolutely. We will be happy to come to you. Just let our staff know if you desire this service.

Where are necessary preparations made and where does the deceased stay between the time of death and the service?

All preparation is done on site at our funeral home.

When you come to make arrangements, what do we need to have from you?

- Deceased's Clothing (including undergarments)
- Social Security Number
- Obituary Information
- Photo for Obituary
- Military Discharge Information (if Veteran and you would like a flag and marker provided)
- Form of Payment (Cash, Check, Credit Card, or Life Insurance)

We have no church. Can you provide a facility for the funeral?

Yes. We have a beautiful chapel that you are welcome to use for a funeral or memorial service.

I have made pre-arrangements at another establishment. Can we change and use Heckart Funeral Home?

Certainly. You do not need to do anything. We can arrange to transfer the pre-paid funds after the death occurs.

I have made no plans. Can I pre-pay or pre-arrange my own funeral?

Yes. We offer pre-paid funeral options and would be glad to discuss those with you.

Should I plan my own funeral or that of a loved one in advance?

As with many events in our lives, a death involves making decisions in a very short period of time. Planning in advance can spare you or your family the difficulty of making these decisions while grieving.

Planning in advance also gives you the opportunity to compare facilities, prices, and options and to discuss your choices with your family.

What options are available to me?

A funeral, memorial service, burial, entombment, cremation, scattering at sea, or inurnments are just a few of the options available. You may also wish to consider a donation to medical science. Exploring these options before the need arises lets you decide what is best for you and your family.

If I decide to make pre-need funeral and/or pre-need cemetery arrangements, how do I select a reputable service provider?

All funeral establishments in Missouri are regulated by the Missouri State Board of Embalmers and Funeral Directors.

Once I've decided which funeral arrangements are right for me and my family, what should I do next?

Memorialize these choices in a written pre-need plan. Most funeral establishments offer pre-arrangement guides you can complete and keep with your other important records to share with your family. You may also wish to place this information in a Will.

I've decided which funeral arrangements are right for me and I have completed documents stating what I want. Can my instructions be changed?

If your instructions are clear as to what arrangements you want and you have made provisions to pay for them to be carried out, only you can change them before they are needed. The exception to this would be if you leave written instructions stating the arrangements can be altered after your death; otherwise, Missouri law states they must be followed.

Should I consider paying for my pre-need choices before they are needed?

Making provisions to pay for the costs of pre-need funeral choices accomplishes several things. Pre-paying removes the burden of the costs of your final expenses from your survivors, ensures your wishes can and will be carried out, and keeps you in control of the costs involved.

Are there different ways to pre-pay pre-need expenses?

Yes. There are several commonly used methods: life insurance, funeral insurance, funeral trusts, bank held trusts, and others. Each has its own advantages and disadvantages. Heckart Funeral Home locks in the costs of the funeral if you choose to pre-pay.
