THE MISSION OF THE FLAGLER COUNTY FREE CLINIC IS TO PROVIDE HIGH-QUALITY, FREE MEDICAL CARE TO THE MEDICALLY UNINSURED, ECONOMICALLY DISADVANTAGED PEOPLE OF OUR COMMUNITY REGARDLESS OF RELIGIOUS, RACIAL OR SEXUAL IDENTITY. THE CLINIC PROVIDES PRIMARY CARE AND A MEDICAL HOME FOR CITIZENS THAT IF IT WERE NOT FOR THE CLINIC WOULD NOT HAVE ACCESS TO MEDICAL AND DENTAL CARE. MOST OF OUR PATIENTS SUFFER FROM LONG-TERM, CHRONIC AND OFTEN DEBILITATING CONDITIONS INCLUDING DIABETES, HYPERTENSION, LUNG DISORDERS, SEIZURE DISORDERS, AND MANY OTHER SERIOUS CONDITIONS. BY PROVIDING HEALTH CARE AND NEEDED MEDICATIONS, WE AIM TO IMPROVE THE HEALTH OF OUR NEIGHBORS SO THEY CAN LEAD A HEALTHY LIFE, POSSIBLY ALLOWING THEM TO OBTAIN GAINFUL EMPLOYMENT, TO BETTER SUPPORT THEMSELVES AND THEIR FAMILY. THE CLINIC IS A 501(C)(3), NON-PROFIT THAT PARTICIPATES IN FLORIDA'S VOLUNTEER HEALTH CARE PROVIDER PROGRAM THAT ALLOWS PRIVATE LICENSED HEALTH CARE PROVIDERS TO VOLUNTEER THEIR SERVICES TO THE MEDICALLY INDIGENT RESIDENTS OF FLORIDA WITH INCOMES AT OR BELOW 200% OF THE FEDERAL POVERTY LEVEL AND WHO HAVE NO HEALTH INSURANCE. THE HUNDREDS OF HOURS OF VOLUNTEER TIME EQUATE TO #306,088 IN PROGRAM SERVICES AT THE FLAGLER FREE CLINIC. OUR 2021 AUDIT REPORTED THAT THE CLINIC USED 90% OF ITS TOTAL EXPENSES TOWARDS OUR PROGRAM SERVICES. IN ADDITION, THE CLINIC RECEIVED ALMOST \$110,800 WORTH OF FREE MEDICATIONS FROM TWO SURPLUS PHARMACEUTICAL COMPANIES, THAT ARE PROVIDED AT NO COST TO OUR PATIENTS. THE CLINIC HAS PURCHASED JENNI TRANSLATION SERVICES FOR OUR NON-ENGLISH SPEAKING PATIENTS.
