VETERANS ARE PRIMARILY REFERRED TO MPFV BY THE VETERANS ADMINISTRATION (VA) AND ARE REQUIRED TO REMAIN IN THERAPY WHILE PARTICIPATING IN OUR PROGRAMS. IN ALIGNMENT WITH ASSISTANCE DOGS INTERNATIONAL, THE GOLD STANDARD FOR ASSISTANCE DOG TRAINING, MPFV HAS A LICENSED PSYCHOLOGIST ASSESS EACH VETERAN THROUGH AN INTERVIEW PROCESS BEFORE INTAKE.
