Note: A non-refundable \$100 registration fee per student, payable to St. Joseph School, must accompany each student's registration. This fee is not included in the rates below. The tuition fee does include \$40 for field trips excluding the 8th grade end of the year field trip.

Note: When determining if the first, second, third, or fourth student rate applies, only include children enrolled in 5K-8th grade.

### Payment Options

The first tuition payment will be due August 31. A tuition agreement form will be emailed to you in early July, allowing you to select from lump sum payment (due by August 31) or flexible payment options administered by the school office through a tuition management system called FACTS. Benefits of FACTS include flexible payment options that best suit your family's needs, on-demand receipts for tax purposes, and reduced administrative expenses for the school. We are also considering offering FACTS as a means of paying incidental expenses in the future. A \$20-\$50 fee is required when enrolling in the FACTS program. Please see the reverse side for answers to frequently asked questions about FACTS.

### Financial Assistance Options

In addition to multi-student discounts and flexible payment options through FACTS, here are some ways to help make tuition affordable for your family:

- **Parish Support** - The cost of tuition is *less than the actual cost* of educating each student because of the financial support of St. Joseph parishioners. You do not need to be a parish member to receive this discounted tuition rate.
- **School Choice** - Students whose families meet certain income qualifications can apply to attend tuition free. Please visit <https://dpi.wi.gov/choice> to see if you may qualify. This year's Wisconsin Choice application period starts **2/2/26**.
- **Wisconsin Tax Credit** - Parents with students in 5K-8th grade at a Catholic grade school may deduct up to \$4,000 per student, per year, regardless of income. If your student moves from grade 8 to Catholic high school in the same tax year, you may claim both tuition expenses up to \$10,000. **Refer to your tax advisor for full details and any questions.**
- **RaiseRight (formerly SCRIP)** - Families earn rebates from purchases they already make - such as groceries and gasoline - to put towards tuition.
- **529 Plans** - Effective January 1, 2018, distributions for tuition in connection with enrollment or attendance at an elementary or secondary public, private, or religious school are federal and Wisconsin income tax free up to a maximum of \$10,000 of distributions for such tuition expenses per taxable year per beneficiary from all 529 Plans.
- **Angel Fund** - Families in need of emergency financial assistance can apply for help through St. Joe's Angel Fund. Your payment schedule is set by your school and your financial institution will decide the time of day your payments are processed.

### What Happens When My Payment Falls On a Weekend or a Holiday?

Your payment will be processed on the next business day.

### What Happens If a Payment Is Returned?

Returned payments may be subject to a FACTS returned payment fee. Watch for a returned payment notice for additional info.

### How Do I Make Changes Once My Agreement Is in the FACTS System?

Changes to your address, phone, email, or banking info can be made at [Online.FACTSmgt.com](https://online.factsmgt.com) or by contacting your school or FACTS. Changes to payment dates/amounts must be approved by the school and they will notify FACTS.

### What Is the Cost to Set Up a Payment Plan?

If an enrollment fee is due, the fee amount is indicated when setting up your agreement. If applicable, the nonrefundable FACTS enrollment fee will be auto processed within 14 days of the agreement being posted to the FACTS system.

\*All changes must be received by FACTS at least 2 business days before auto payment date to affect upcoming payment.
