As of today, the merger of Ryerson and Olympic Steel is complete, and we are one public company. In the coming weeks, the combined company will begin trading under a new ticker symbol, RYZ, on the New York Stock Exchange (NYSE). This symbol combines the former Ryerson ticker, RYI, and the former Olympic Steel ticker, ZEUS.
