Up to 10 renewable scholarships in the amount of \$2,500 each will be awarded during the 2026-2027 school year for full-time, undergraduate educational programs through vocational/technical institutions or accredited colleges and universities.

Recipients may retain the scholarship for up to three additional academic years within a five-year period by:

- ✓ Meeting all renewal criteria
- ✓ Maintaining satisfactory academic performance (at least a 2.5 GPA on a 4.0 scale)

**SELECTION
CRITERIA**

Olympic Steel partners with Scholarship America, who independently selects scholarship recipients, ensuring third-party objectivity. Financial need is not considered in the selection process. Rather, scholarships are awarded according to the following criteria:

- ✓ Good academic standing
- ✓ Letter of recommendation from a work supervisor or community leader for an organization in which the applicant is involved
- ✓ If applicable, one award will be granted to an applicant attending a 2-year or vocational-technical school.

ELIGIBILITY REQUIREMENTS

- ✓ Dependent* child or legal dependent of an Olympic Steel, Action Stainless, Berlin Metals, Central Tube & Bar, Chicago Tube & Iron, Integrity Stainless, McCullough Industries, Metal-Fab, MetalWorks or Shaw Stainless & Alloy employee (*parent/guardian must work a minimum of 24 hours per week when the award check is distributed*)
- ✓ Current high school senior, high school graduate, or college student enrolled in a full-time** vocational/technical or post-secondary undergraduate program
- ✓ Dependent of an employee who has completed a minimum of one year of continuous employment prior to the application deadline

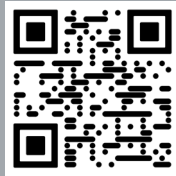
**Dependent children are defined as natural and legally adopted children, stepchildren or legal wards living in the employee's household or primarily supported by the employee.*

***Full-time study is defined as full-time enrollment for the entire upcoming academic year.*

SCHOLARSHIP RENEWALS

Scholarship awards may be renewed at \$2,000 for up to three years within a five-year period for full-time, post-secondary undergraduate programs. Renewal applicants will be asked to provide Scholarship America with the following materials each year the renewal is requested:

- ✓ Completed renewal form
- ✓ Complete copy of the student's post-secondary transcripts

Renewals will be issued to the children or legal dependents of deceased, permanently disabled or retired employees.

However, renewals will not be issued for individuals whose parent or legal guardian is no longer employed for any other reason. Scholarship America will send renewal materials and information directly to scholarship recipients.
