Security Camera System:

For increased security and safety regarding our residents, staff, families, and visitors, we have recently installed a “Spaco Technologies Security Camera” system throughout the nursing home campus. The new system will allow us to videotape areas within the facility as well as out-of-the facility (entryways and exits, hallways, dining room, and other common areas). The camera records nursing home activity in these areas 24 hours a day.

Family Council:

- To protect and improve the quality of life in the home and within the long-term care system as a whole
