

About the House

Nestled amongst the pine trees and within view of Wellfleet Bay, the Lily House provides residents with holistic care in a beautiful and peaceful home adorned throughout with joy-inspiring art by Outer Cape artists.

We provide an end-of-life home for a maximum of two residents at a time. Each resident has their own private bedroom with an en suite bathroom and space for a family member or friend to stay overnight, especially during active dying.

All residents, as well as their friends and family, have access to shared community spaces, including a cozy living room with gas fireplace, a well-stocked kitchen, a dining room with French doors opening onto a wrap-around deck, and a respite room for reflection and contemplation.







The Story Behind the Name

Remarkably, the Lily House logo preceded its name. Truro printmaker **Vicky Tomayko** designed a poster for the 2016 Provincetown Day of the Dead celebration, which included a song bird with a lily in its beak making an offering to the dead.

When co-founders Dawn, Hannah, and Paula were thinking creatively about a name, they knew they wanted something connected to the natural world. Vicky's bird with a lily offering was a perfect representation of their vision—acknowledging death as a natural part of life and honoring the sacredness of dying.



Community-Centered Care

Our social model of community-centered care is at the heart of our mission. We offer personalized end-of-life care in a home environment where human connections are cultivated and nurtured. We support our residents to live as fully as possible until the time of death.

Lily House staff and community volunteers work together to provide our residents with skilled care, meaningful companionship, gentle guidance, and a peaceful presence during their dying experience. We also care for their family and friends, supporting them on their emotional journey and encouraging them to make themselves at home at the Lily House.

Our care is holistic, tending to the physical, social, emotional, and spiritual needs of our residents—and continues past the moment of death. Our after-death care includes laying our residents in honor, hosting family gatherings and community wakes, and leading shrouding ceremonies.

We focus on providing the highest quality end-of-experience for all—our residents, their family and friends, and our staff and volunteers—which holds potential for profound insight and transformation. Together, we are modeling what it looks like to care for each other in death.

Our staff works closely with each resident's hospice team, including the hospice nurse, to ensure our residents receive the highest quality care possible. Our hospice partners—Beacon Hospice, Broad Reach Hospice, and VNA Hospice—are vital to our model of care at the Lily House, and we are grateful for their support.


