## The following conditions need to be understood before enrolling.

1. Course consists of a minimum of 14 periods (7 periods of observation and 7 periods of driving). The schedule will be agreed upon prior to the first lesson. Adjustments may be made during the course if needed.

- 2. Students will be notified by phone, e-mail and/or via website in the event VDS cancels classes. Cancelled classes will be made up at the end of the course or during an alternate day.
- 3. A minimum of 24 hours notice by the student is required for cancellation of Behind-The–Wheel lessons. Failure to comply may result in a charge of \$30. When canceling, the student or a parent must speak to the instructor. Cancellations must be sent to the instructor via text or a phone call on the instructors contact number.
- 4. To retest for a license due to failing the road test, there will be \$55 fee. Lost or misplaced DTS-B will be re-issued for a processing fee of \$25.
- 5. **A Fee of \$50.00** will be charged for any insufficient funds or stop payment of a check that is returned by a bank. Issuer of the check will be responsible for all legal expenses.
- 6. Sleeping or cell phone usage is not allowed during driving or observation.
- 7. Any student suspected of being under the influence of alcohol or drugs while attending class or road instruction will be immediately expelled from the program. A conference will be held with their parent/guardian as well as the local law enforcement officials being contacted. Also, **NO refund and DMV will be notified**.
- 8. ATTITUDE and MATURITY are an important part of this course. Any student who is found to be DISRUPTIVE or DISRESPECTFUL to the instructor, other students or anyone associated with Valley Driving School, shall be dismissed by the instructor at the instructor's discretion. NO refund from the program will be given.
- 9. **Traffic Violations during drive time** -Student drivers must obey all traffic regulations and speed limits.

  Any violations that occur during their drive time that result in a ticket or summons, the driver is responsible for the payment of the fine.

## Fees and Refund Policy:

All fees will be collected on the first day of instruction. For notice of withdrawal received on the first day of classes/lessons and before the second day of classes/lessons, a refund of fifty percent of total tuition will be granted. A refund of all fees paid will be made, upon request, if school is not capable of or willing to begin instruction within 30 calendar days from the date agreed to in the contract. **No refund** of tuition will be granted for Behind the Wheel students beyond the third day of a class and/or driving lesson.
