Questions & Answers

What is pledging?

Pledging is the act of committing to a giving amount for next year. It is spiritual practice to show gratitude for God's many gifts.

When we pledge, we make an intentional choice and then do our best to fulfill it. Our pledges together help the comptroller, finance committee, and vestry make prudent financial plans for the coming year.

How will my pledge be used?

Revenue from pledges goes to all that we are and do as a faith community. Our clergy, lay staff, buildings and grounds, worship ministries and outreach are all supported by your generosity. In this season of transition, your support is even more important and appreciated as we prepare our parish for a new Rector.

How do I begin the practice of pledging?

Think in terms of a proportion of the income you receive, either weekly, monthly or yearly. The biblical standard is a tithe, or 10%. Start with a manageable percentage such as 2.5 percent. If you have achieved that, work toward stepping up another 2.5 percent each year.



Ways of Pledging & Giving

Pledging & Giving via Your Realm Account

Using your Realm account is a simple way to make and pay your pledge for 2026. If you choose to use this method, go to your Realm Connect app, tap the Giving button at the bottom of the screen, and choose Pledge on the top of the screen. The next page will allow you to choose the Annual Fund Pledge button.

Pledging & Giving via the Bruton Parish Website

You may also use the website at www.brutonparish.org to make your pledge and give. It allows for the use of a credit card, debit card, or secure electronic transfer (ACH). It also offers a recurring gift option, on the schedule of your choice. You may opt to cover the additional processing fee at the time of transaction. Texting Bruton at 73256 is also a way to give.

Pledging & Giving by Check or Cash

By mail or in the offering plate. Offering envelopes are not required. Cash may be placed in a plain envelope. Write your name on the front and we will apply the amount toward your pledge.

Gifts of Stock

Donate appreciated securities or mutual funds held longer than one year and receive a tax deduction without paying capital gains tax. When initiating a stock transfer, please contact Margaret Driscoll in the Development Office at (757) 345-2256 or mdriscoll@brutonparish.org. Occasionally, we receive stock gifts with no donor identification, so to avoid this, it's helpful for the church office to know a stock gift has been put into process. Provide your broker the following for Bruton's Fidelity Investments brokerage account:

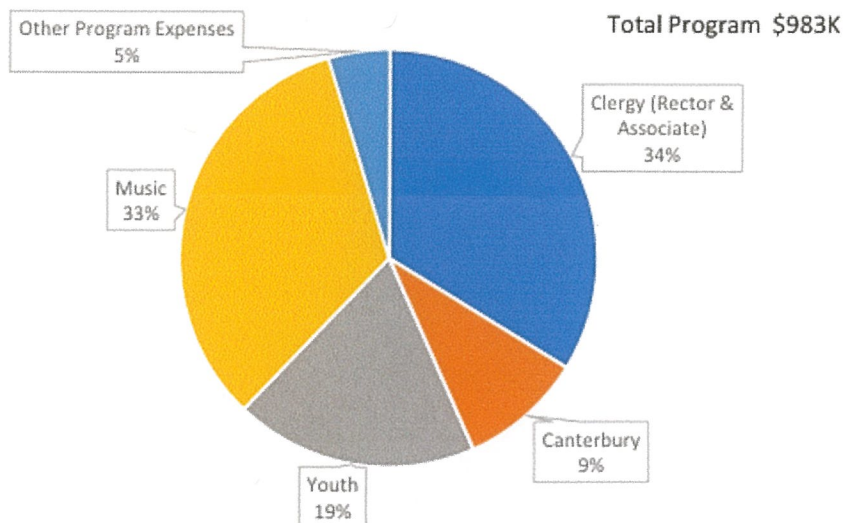

When you initiate a stock transfer, please contact Margaret Driscoll, who will watch for the shares and sell them promptly.

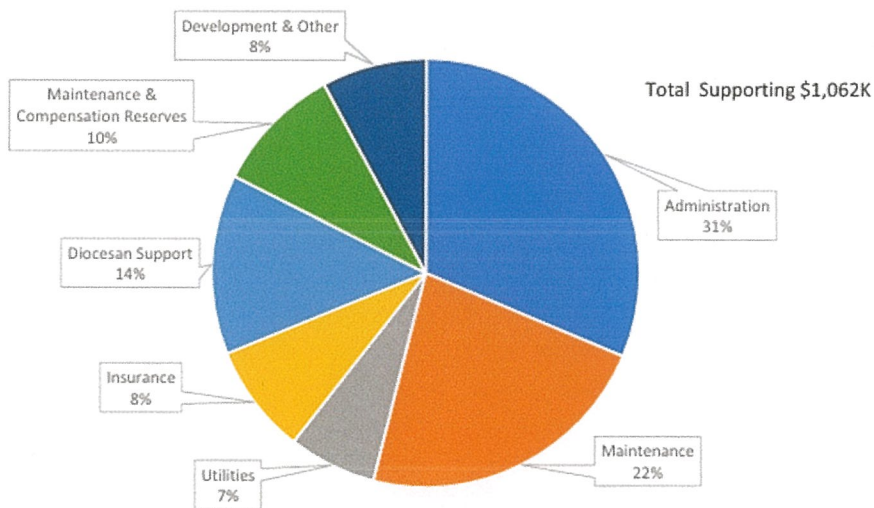
A Look at Projected 2026 Finances

Gifts from an IRA

Those 70.5 years of better may make a Qualified Charitable Distribution directly from an IRA. Qualified charitable deductions are not included in income, so for those who take the standard deduction, there is a significant tax benefit. Provide your IRA custodian this information for sending a check: Bruton Parish Church, P.O. Box 3520, Williamsburg, VA 23187-3520 Attn: Finance Office, EIN # 54-0519571, and your name.

Statements are sent periodically during the year and you may request one at any time. Due to the tax law change, there is a small advantage to giving your

2026 gift in 2025 (if you itemize your deductions). If you choose to pre-pay in the fourth quarter of 2025, please indicate that this is your intent when making the gift.

Contribution statements are sent quarterly during the year and you may request one at any time. Your giving is also available to you to review through your Realm account.
