A newly created fund receiving gifts and pledges for a closed loop geothermal heating & air conditioning system for the church.



T his seal is recreated from an earlier one and rendered here in color. Around the outside border are key years in Bruton Parish history: 1633 to mark the first brick church and 1715, the third and present church. 1674 and 2024 are for the parish founding and upcoming 350<sup>th</sup> anniversary year.

The inside seals are unchanged and depict the two entities from which Bruton Parish sprang and belonged (the Diocese of the City of London and the Diocese of Virginia) and the one in which it remains today, the Diocese of Southern Virginia.



This updated seal speaks to the enduring witness of Bruton Parish Church, proclaiming and sharing the message of the Risen Lord. For the small number who founded the parish, the many who followed, and for those yet to come, this seal is recreated in thanksgiving.




