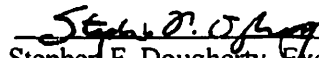

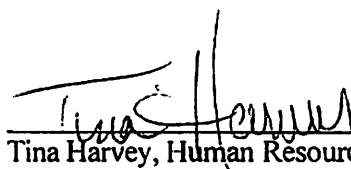

Job Summary:

Under general supervision of the Airport Facilities Manager performs duties associated with the maintenance and repair of all Airport grounds, building systems and facilities.

Job Responsibilities:

- Actively participate in the day-to-day maintenance activities associated with the operation of Atlantic City International Airport.
- Must be available to respond as needed when requested by senior management to any airport emergency condition, including but not limited to snow emergencies.
- Troubleshoot complex mechanical operating systems.
- Learn and become proficient with the operations of all airport snow emergency equipment and perform snow removal services on both the public roadway system as well as the Airport Operations Area including runways, taxiways, service roads, ramp areas and perimeter roadways.
- Operate all airport equipment needed to perform any and all maintenance tasks, including but not limited to landscaping, crack sealing, etc.
- Perform maintenance and repairs of Airport Owned buildings, including but not limited to roof repairs.
- Perform maintenance and repairs of Airport owned land and grounds.
- Perform maintenance and repairs of all Airport hard surfaces (i.e. asphalt and concrete), including snow removal, crack sealing, asphalt patching, line striping, etc.
- Perform maintenance and repairs of the Airport utility systems including water, sanitary sewer and storm sewer as required.
- Perform maintenance and repairs on Airport baggage conveyors, passenger boarding bridges, automated doors, automated vehicle gates and other facility systems as requested.

- Operate power tools and miscellaneous hand tools.
- Perform other duties as assigned.

Knowledge and Abilities:

- Read and understand manufactures manuals, diagrams, schematics and instructions.
- Ability to train Airport Facility Maintenance 2 & 3, as needed.
- Use computer applications (Microsoft Excel, Word, etc.).
- Estimate materials and man-hours for projects.

Physical Requirements:

- Ability to physically perform the duties and to work in the environmental conditions required of a position in this class, including the operation of all equipment needed to perform the functions of this job.
- Ability to work outside in all weather conditions.
- Ability to lift 50 pounds waist high.
- Ability to work at high elevations.

Education:

- High school diploma or equivalent.

Experience:

- Minimum of five (5) years of experience in general facility maintenance to including buildings, grounds, asphalt, concrete, HVAC etc.
- Experience in preventative maintenance techniques with the ability to troubleshoot various maintenance issues and make or recommend repairs.
- Experience and/or aptitude in all building and facility systems including, baggage conveyors, loading bridges, HVAC, sprinkler systems, generators, PLCs.
- Experience in general plumbing repairs and maintenance
- Experience in landscape and grounds maintenance techniques including but not limited to operation of snow plows (skid steer, bobcats, hustlers, tractors).

Licenses and/or Certificates:

- Valid State of New Jersey driver's license.
- Valid Commercial Driver License (CDL). Must have or be able to obtain one within six (6) months of hire.
