Personnel Matter-Schedule "A": Resolution 2025-72

Paul Heck addressed the Board to discuss Schedule "A" regarding Personnel Actions associated with Resolution 2025-72.

Mr. Heck noted the Authority's 2025 budgeted headcount of 327 positions and the current staffed headcount of 305. Mr. Heck provided a summary of the positions and the various vacancies, including 1 new hire for a vacant budgeted position and 3 backfill positions due to promotion or retirement. He briefly noted that two part-time positions for drivers and one welcome center customer service position were filled. Mr. Heck noted that the Authority is monitoring its expenses and hiring as needed. A correction for the record was also made for two SJTPO salaries approved at the July 16, 2025, board meeting.

<u>Litigation: Woods v. SJTA</u>

Mr. Heck introduced Mike Watson to the Board to present Woods v. SJTA. Mr. Watson gave a history of her employment at the Authority and the actions leading up to the complaint filed in November of 2023.
