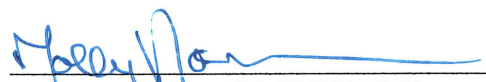

LOCAL ACCESS CHANNEL MANAGER CONTRACT

The City of Dickson, Tennessee, agrees to secure the services of Dan O'Connell, 1460 Spencer Mill Road, Burns, TN 37029, in the capacity of Manager of the Local Access Cable Television Channel owned and operated by the City.

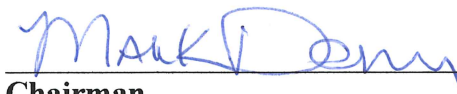
Duties of the Manager include, but are not limited to, programming the Local Access Cable Television Channel, maintaining and operating the equipment necessary for continuous broadcasting, and performing other duties necessary to its operation, as defined by the Local Access Cable Television Channel Committee.

For and in consideration of the above-described services, the City of Dickson agrees to pay Dan O'Connell the sum of fourteen thousand four hundred dollars (\$14,400.00) per year to be disbursed in monthly installments of twelve hundred dollars (\$1,200.00) from the city's General Fund.

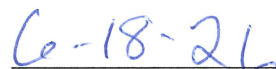
The term of this contract will be for one (1) year beginning July 1 and expiring June 30 of each year.

The contract will be presented to the Local Access Cable Television Channel Committee for renewal each year and, following approval, presented to the Dickson City Council for final approval.

This contract can be terminated by either party for any reason with 30 days' written notice.
