Application must be submitted a minimum of 21 days prior to the event and may be submitted up to 180 days prior to the event.

A non-refundable application fee of \$125 is due with submission. Application must be complete, including signature page(s).

Applicant must submit a certificate of event liability insurance for \$1,000,000.00 naming the City of Dickson as a covered party.

Fireworks displays must comply with Dickson Municipal Code Title 7 and all other Ordinances and Statutes. Applicant shall submit a letter of permission from the authorized representative/owner of the display location. Fireworks displays/locations must be approved by the City of Dickson Fire Marshal.

Vendors shall be responsible for obtaining all permits and licenses and the collection of all required sales taxes.

Vendors preparing food on-site shall be responsible for providing adequate fire safety protection.

Mobile food vendors must comply with all applicable local ordinances, state statutes and health regulations.

Vendors that include deep frying cooking oil operations must contact the Water Authority of Dickson County for required permits and/or temporary water tap and are responsible for the safe removal of all discharged grease.

Applicant shall include a Good Neighbor Petition with the signature of the owner/authorized representative of EVERY business directly affected by the proposed event by either restricting access through the closure of a street/alley, installation of temporary structure(s) or vendor booth(s) or any other activity associated with the event. Petition shall include the name of the business, address and signature of an authorized agent acknowledging notification of the event listed in the application and indicating support/opposition/no opinion regarding the event. Petition must indicate support or no opinion of at least 75% of the affected businesses. Failure to notify EVERY affected business or obtain the expressed support or no opinion of 75% of the affected businesses may result in denial of the permit and forfeiture of the application fee.

By signing this form, the Applicant/Sponsoring Organization:

- 1) Agrees to abide by all ordinances and regulations of the City of Dickson, statutes of the State of Tennessee and all conditions placed upon the event by the City Administrator, Mayor, City Council or authorized department head.
- 2) Affirms that all of the information provided herein is true and complete.
- 3) Agrees to assume the defense of and indemnify and hold harmless the City of Dickson, its employees and officials, boards and commissions, officers and agents from all lawsuits, actions, damages or claims to which the City might be subjected of any kind or nature whatsoever resulting from, caused by or arising out of or as a consequence of the event specified in this application and the activities permitted in connection therewith, and to **submit a certificate of insurance prior to the event in the amount of one million dollars (\$1,000,000.00) naming the City of Dickson as a covered party, when applicable.**
- 4) Agrees to provide a signed copy of this Event Application and any appropriate rules, restrictions and/or regulations to all vendors, planners and other parties associated with the event to ensure they are informed of and will comply with the guidelines herein.
- 5) Understands that it assumes responsibility for the actions of any vendors, planners and other parties related to this event. Applicant may choose to require event insurance from all participating vendors and, if so required, shall maintain proof of coverage.
- 6) Understands that the granting of a Special Event Permit does not imply granting of any other permit/license that is separately required.
- 7) Understands the application for a Special Event Permit shall not be submitted to the City of Dickson less than twenty-one (21) days nor more than one hundred eighty (180) days prior to the scheduled date(s) of such event. **Events should not be advertised or promoted until a Special Event Permit has been obtained from the City of Dickson.** Failure to file in a timely manner may result in denial of a permit.

- 8) Understands the City of Dickson reserves the right to require one or more City of Dickson Police Department officers or other emergency personnel be present at any and all events at the sponsoring organization's expense at a rate of twenty-five dollars (\$25.00) per hour for a minimum of two (2) hours.
- 9) Understands that all signage must abide by the City of Dickson's Municipal Sign Ordinance, including required sign permits.
- 10) Understands that all mobile food vendors must be in compliance with the City of Dickson's Mobile Food Vendors Ordinance.
- 11) Understands that the City of Dickson through its authorized agent reserves the right to cancel an event due to threatening weather or other event.


**CITY OF DICKSON
SPECIAL EVENT PERMIT
BEER/ALCOHOL SALES RESTRICTIONS**

Any business licensed by the City of Dickson and/or the Tennessee Alcoholic Beverage Commission to sell beer and/or alcoholic beverages for consumption on premises may establish a temporary area outside of its premises for the sale and consumption of beer and/or alcoholic beverages under a Special Event Permit issued by the City of Dickson under the following restrictions:

- a) A Special Event Permit shall be issued only for a specified period and shall not be valid for more than that time;
- b) An application for a Special Event Permit must be filed with the City of Dickson no less than twenty-one (21) or more than one hundred eighty (180) calendar days in advance of the effective date(s) sought for the permit;
- c) The business must be permitted/licensed by and in good standing with the City of Dickson and/or the Tennessee Alcoholic Beverage Commission for the sale of beer and/or alcoholic beverages for consumption on the premises. The business shall not be under investigation for or have any citation(s) pending for violation(s) of the ordinances of the City of Dickson or the statutes of the State of Tennessee regarding the sale of beer and/or alcoholic beverages. The permit/license shall be current and valid and shall not be suspended or expired during any period for which a Special Event Permit is issued;
- d) The Special Event Permit shall define the specific hours and date(s) for which the sale of beer and/or alcoholic beverages on temporary premises will be conducted, which must conform to the restrictions on the sale and/or consumption of beer and/or alcoholic beverages established by ordinance or statute. The sale and/or consumption of beer and/or alcoholic beverages under a Special Event Permit shall not be permitted during any time of day, day of the week, holiday or other period in which the sale of beer and/or alcoholic beverages is prohibited by ordinance or statute;
- e) All ordinances and statutes regarding the sale and/or consumption of beer and/or alcoholic beverages shall apply to the temporary premises established in the Special Event Permit in the same manner as to the business for which the permit/license is issued;
- f) A Special Event Permit shall allow the temporary sale and/or consumption of beer and/or alcoholic beverages in an area outside the premises of the permit/license holder subject to the following restrictions:
 - i. The temporary premises shall be immediately contiguous to the structure of the business that is permitted/licensed to sell beer and/or alcoholic beverages for consumption on premises by the City of Dickson and/or the Tennessee Alcoholic Beverage Commission;
 - ii. The temporary premises shall be restricted to an area at the front or rear of the structure as defined by the side walls of the licensed business and to the center line of the public street or alley immediately adjacent to the structure or to an area at the side of the structure as defined by the front and rear walls of the licensed business and to the center line of the public street or alley immediately adjacent to the structure or to an area not to exceed one half (1/2) of the total square footage of any public or private parking area immediately adjacent to the structure;

- iii. The temporary premises shall be clearly defined by barriers and/or signage and no beer and/or alcoholic beverages sold for consumption in the temporary premises shall be allowed to be taken from or removed for consumption outside the temporary premises; and
- iv. The temporary premises shall allow pedestrian traffic on all public sidewalks to remain open and unencumbered as required under the Americans with Disabilities Act.
- g) The holder of the Special Event Permit shall be responsible for the removal of all tables, chairs, other structures or furnishings, trash, trash receptacles and any other items placed in the temporary premises by the concluding time established in the Special Event Permit;
- h) Any violation(s) of the restrictions on a Special Event Permit contained herein shall constitute a violation of the City of Dickson's ordinance(s) regarding the sale of beer and/or the State of Tennessee's statutes regarding the sale of beer and/or alcoholic beverages and may result in the issuance of a misdemeanor citation(s) to the person committing the violation(s) and a notice of violation(s) to the holder of the permit/license to be enforced and adjudicated according to the ordinances or statutes regulating the sale of beer and/or alcoholic beverages;
- i) Applicants for a Special Event Permit to include the sale of beer and/or alcoholic beverages in a temporary premises shall be furnished a copy of and acknowledge receipt of these restrictions by signature on the Special Event Permit Application;
- j) By the filing of an application for a Special Event Permit with the City of Dickson, the applicant agrees to be responsible for the enforcement of all restrictions contained herein;
- k) The Special Event Permit shall not be valid until it is signed by the Mayor, City Administrator or his/her designee(s); and
- l) The City of Dickson, to include the Mayor, City Administrator, Chief of Police, Fire Chief, Public Works Director, Director of Planning and Zoning or other designee, may deny an application for a Special Event Permit to include a temporary premises for the sale of beer and/or alcoholic beverages if the event might interfere with the health, welfare or safety of the general public or create any hazardous or nuisance situation prohibited by ordinance or statute.






