

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR and STAFF.....\$1,895
 This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select (this fee is already included in our charges for direct cremations, immediate burial, and forwarding or receiving remains); arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary permits, authorizations, and certificates; recording of vital statistics; composing and placement of obituary notice; and coordination with those providing other portions of the funeral, (cemetery, crematory, vault company, minister, and musicians). Also included in this charge are overhead expenses relative to our facilities such as licensing, legal and accounting fees, insurance, building and utility expenses, parking lot and grounds, maintenance, taxes, equipment, furnishings, record keeping, secretarial, and administrative expenses.

EMBALMING.....\$795

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation, or immediate burial.

WARRANTIES

The only warranty on the caskets, outer burial containers, or any merchandise sold in connection with this service, is the express, written warranty, if any, granted by the manufacturer. The funeral home makes no warranty, express or implied, including an implied warranty of merchantability and implied warranty of fitness for a particular purpose, with respect to the casket, outer burial container, or any merchandise sold.

Note: North Carolina state laws require a 24-hour waiting period from the time of death until cremation, except in cases of infectious diseases listed by the commission of health services pursuant to G.S. 130-A-134. In addition, no cremation may take place until a death certificate signed by the certifying physician has been received or authorization for cremation by medical examiner G.S. 90-210.45-A.

If the state requires medical examiner authorization in order to cremate, the fee is \$50.00.

TRADITIONAL CREMATION SERVICE.....\$3,975
 Services of funeral director and staff, transfer of remains to funeral home, (within a 25 mile radius), embalming, other preparations of the body, use of visitation room, use of chapel for funeral ceremony, or staff and equipment for off premises ceremony, hearse for transfer to crematory, and utility vehicle.

Note: This service does not include the cremation container, (alternative container or cremation casket), cremation urn, urn vault (niche), staff and equipment for committal service at a cemetery, or the cremation fee.

MEMORIAL SERVICE.....\$3,295
 Services of funeral director and staff, transfer of remains to funeral home, sheltering of remains for 24 hours, hearse for transfer to crematory or to place of body donation, (within a 25 mile radius), use of visitation room, use of chapel for memorial service, or staff and equipment for off premises memorial service.

DIRECT CREMATION.....\$1,495 – \$4,545
 The charge for direct cremation includes the removal of remains from the place of death, (within a 25 mile radius), sheltering of remains for 24 hours, transportation to the crematory, securing necessary authorizations and permits, a proportionate share of overhead costs, and basic services of the funeral director and staff.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body, and can be made of materials like fiberboard, and composition materials (with or without outside coverings). The containers we provide are made from basic cardboard.

IMMEDIATE BURIAL.....\$2,595 - \$9,620
 The charges for immediate burial include removal of the deceased from place of death, (within a 25 mile radius), local transportation to cemetery, graveside tent, necessary authorizations, a proportionate share of overhead costs, and basic services of funeral director and staff. This charge does not include a casket or alternative container. It does not include services or facilities for visitation, or ceremony, public or private, prior to burial.
 1. Immediate burial with casket selected from funeral home.....\$2,595 (in addition to casket selected)
 2. Immediate burial with casket provided by the purchaser.....\$2,595

FORWARDING REMAINS TO ANOTHER FUNERAL HOME.....\$2,195
 This charge includes basic services of funeral home and staff, removal of the deceased from the place of death, (within a 25 mile radius), embalming, obtaining necessary authorizations, a proportionate share of overhead costs, and transportation to Greensboro, NC airport. This charge does not provide visitation, ceremony, casket, air fare, or air tray.
 1. With minimum transit container.....\$2,445
 2. With casket selected from our funeral home (add cost of the casket).....\$2,195
 3. Shipping Container.....\$250

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME.....\$1,695
 This charge includes receiving of remains, transportation to cemetery, or crematory, a proportionate share of overhead costs, and basic services of staff. This charge does not include facilities or services for visitation or ceremony, public or private, prior to burial.

DIRECT ANATOMICAL DONATION.....\$595
 Includes staff and local transportation for Anatomical Donation.
