# INTRODUCTION

---

To the Oldham County Fiscal Court

The Adopt Me! Bluegrass Pet Rescue (AMBPR) respectfully requests a grant for \$5,000 to support our community based, non-profit serving Oldham County residents and the health of their pets. This grant will support Oldham County residents who are overwhelmed by an unexpected litter and cannot afford to keep the offspring nor spay/neuter surgery for their adult pets.

AMBPR's **Last Litter Program** provides assistance to pet owners in Oldham County and surrounding communities who are overwhelmed by an unexpected litter but cannot afford spay/neuter surgery for their adult pet. This funding will provide as many as **25 spay/neuter surgeries for the adult pet**, which the owner keeps, thus ensuring no more unwanted litters are produced. We then take the puppies or kittens from the current litter into our adoption center to receive proper care until they can be adopted into safe, loving homes. This initiative benefits Oldham Countians by giving owners peace of mind and preventing further unwanted litters.

# 1. ORGANIZATION PURPOSE AND SERVICES

---

**Established in 2014, Adopt Me! Bluegrass Pet Rescue (AMBPR)** is an incorporated, non-profit 501(c)(3) organization guided by the principles of compassion, integrity and dedication. Since our inception in 2014, we have saved almost 4,000 homeless, abused, and neglected companion animals. We are an all-volunteer rescue with a network of nearly 200 dedicated, passionate volunteers from Oldham and surrounding counties.

The foundation of our daily operations is to Rescue, Rehabilitate, and Rehome (through adoption) homeless, abused, and/or neglected companion animals. Our mission is to work with and educate the people of Oldham County and surrounding communities in order to make a positive impact on pet overpopulation. Our goal is to find each of the animals in our care a home to fit their specific needs. To fulfill our mission, our main focus is on rescuing animals from overcrowded shelters for adoption. All animals in the program are fully assessed for health and wellbeing. They are provided spaying or neutering, vaccinations and microchipped before permanent placement. If required, injured or ill pets are afforded the best medical care to return them to health before adoption. The organization continues to serve the community by providing a vital location for youth groups and scout groups to learn about giving their time and taking care of their community, in addition to acting as a headquarters and training space for volunteers and our education outreach programs.

## 2. STATEMENT OF NEED

---

**Last Litter Program Sponsorship:** This funding will be used to sponsor spay/neuter operations through the Last Litter Program, a community outreach initiative focused on reducing pet overpopulation.

- **Statement of Need:** Kentucky consistently ranks near the bottom nationally for animal protection, a crisis reflected locally in the persistent cycle of pet overpopulation that threatens both wildlife and community health. Many Oldham County residents are forced to make heartbreaking choices when faced with unexpected litters, often loving their pets but lacking the financial resources for spay/neuter surgeries.

AMBPR's Last Litter Program directly addresses this gap by offering a "safety net": we cover the cost of sterilizing the adult animal so the owner can keep their companion, while we assume responsibility for vetting and rehoming the litter. This initiative not only secures a future for vulnerable puppies and kittens but empowers residents to remain responsible pet owners, permanently halting the cycle of unwanted litters and preventing unnecessary shelter surrenders.



### 3. PROPOSED USE OF FUNDS

---

This project will assist Oldham County pet owners who may be facing relinquishing or worse, abandoning their pets due to their limited access to critical pet medical services for the mother and her litter. With funds 'earmarked' for this special need, we can more quickly help animals in distress while providing a social service not otherwise available to Oldham Countians.

- **Specific Use:** The \$5,000 will provide assistance for up to 25 pet owners who are overwhelmed by an unexpected litter but wish to keep their adult pet, yet cannot afford the spay/neuter surgery cost. The program ensures AMBPR provides the spay/neuter surgery for the adult pet, preventing any more unwanted litters.
- **Principal Objectives:** This program fulfills AMBPR's mission to work with and educate the community to make a positive impact on pet overpopulation. It ensures that the current litter of puppies or kittens receives proper care within the adoption center until they find safe, loving homes.

By helping these residents keep their pets we will **reduce the number of animal surrenders burdening an already full system** and through spaying or neutering **further control pet overpopulation** in Oldham County.

## 4. PROJECT BUDGET

---

As we use volunteers for transportation and program management, the funding will specifically support the medical costs required to halt the cycle of unwanted litters while keeping adult pets with their owners. The primary use of funds is to cover the cost of the surgery for the adult animal.

Our request of \$5,000 will serve up to 25 Oldham County pet owning families by providing free spay/neuter services.

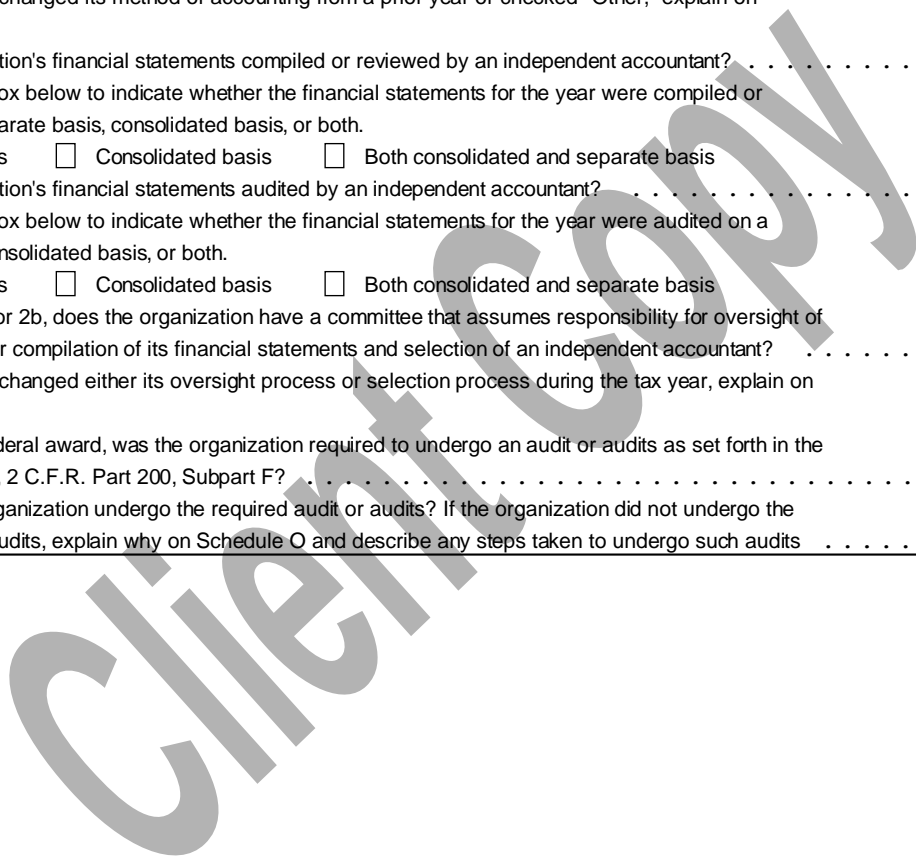

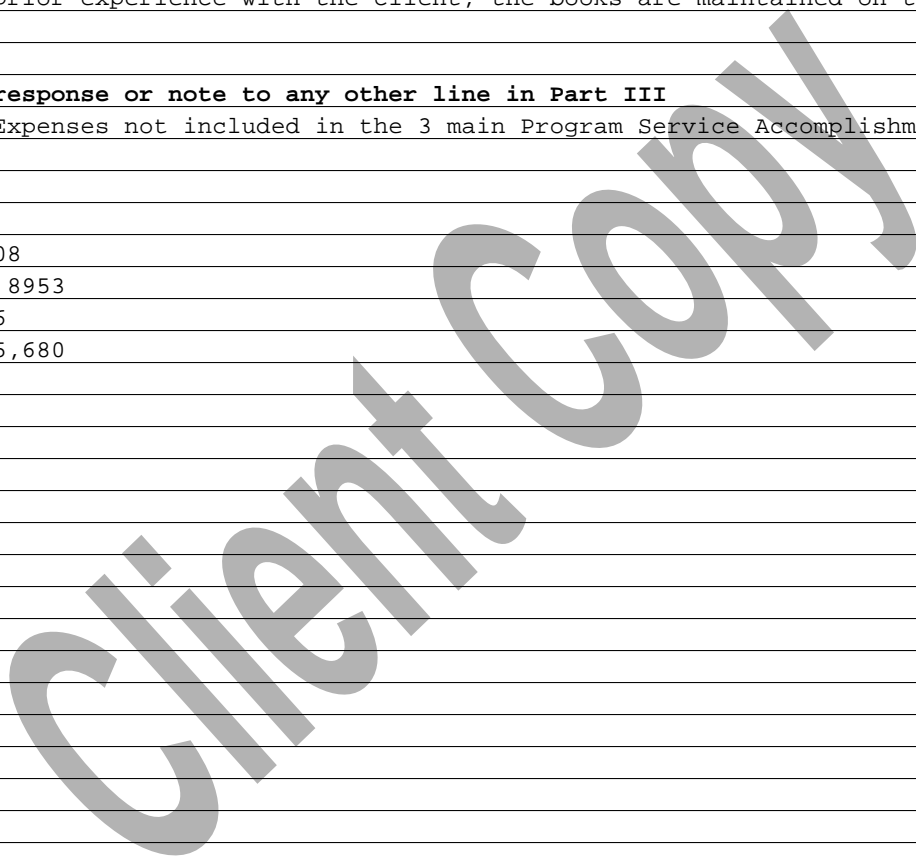
