Statement of need for project

Veterans Memorial Park of Kentucky, located in Crestwood, is a uniquely spectacular venue in Oldham County. What makes it special is that it records military history not just by cataloging wars, campaigns, and battles, but by bringing them to life by highlighting the stories of individuals who bravely secured the blessings of liberty for this great nation. One way we do this is the installation of informational markers throughout the Park.

Each informational marker consists of a concrete footer, a granite pedestal, and a cast-aluminum plate (topper) that contains the inscription. The Park has eleven such markers, and we need seven more to complete our current plan. We have received recent private donations that will allow for the installation of three more, one for Vietnam and two for the Civil War. This leaves four informational markers needed to finish this portion of our Park.

We are grateful for your consideration of this proposal. The Park Board is excited to provide this resource to the Oldham County Community and we look forward to partnering with Fiscal Court.

Proposed use of funds to remediate the need

We are requesting for Oldham County Fiscal Court to provide funding for one topper at a cost of \$3500. This represents about 30% of the entire installation. Funds for the footer have been requested from the Kentucky Colonel's Foundation, and the remaining funds will be raised from the community in the form of revenue from our spring fundraiser or donations. Oldham County Fiscal Court funds will be used to purchase the Texas War topper. Photographs of an existing informational marker are attached to this email.

WW II—EUROPEAN THEATER OF OPERATIONS

The European Theater of Operations geographically encompassed North Africa, Sicily, Italy, France, and the Benelux (Belgium, Netherlands, and Luxembourg). Partly because of its mutual pact with Japan, Germany declared war on America on 11 December 1941. Hours later, the US declared on Germany.

American participation in land combat operation commenced in November 1942 with the "Operation Torch" landing in North Africa. Initially, the newly arrived Americans suffered a major reverse in the Kasserine Pass when confronting experienced and dedicated German Afrika Korps fighters. However, when MG George Patton took command, the tide of the battle turned in North Africa.

The next Allied attack was made upon Sicily in July 1943 which was, until that time, the largest combined amphibious and airborne assault in history. In less than a month the Axis forces of Germany and Italy were soundly defeated although many escaped across the Straits of Messina to fight another day.

The campaign against Italy was the next stop in the Allied juggernaut. The Allied forces advanced rapidly until they were north of Rome where they met determined German resistance combined with numerous small mountain passes which impeded the march north. At the end of the war there were 500,000 German soldiers still in Italy who could have been better deployed to stave off the inevitable defeat of the German Reich.

On D-Day, 6 June 1944, the invasion of the continent, "Operation Overlord", commenced. American soldiers stormed ashore at Omaha and Utah beaches at Normandy while the 82nd and 101st Airborne Divisions jumped from the sky. This was what the German Field Marshal Erwin Rommel termed as the "Longest Day". It was forever etched in history and resulted in the beginning of the end for Nazi Germany.

In the final days of the Normandy campaign, an entire German army led by Marshall Von Kluge was surrounded in Falaise. It is still unclear the number of Germans that escaped but they left an immense amount of irreplaceable equipment.

The Germans were pushed back to Germany almost as rapidly as they previously advanced four years prior. In September 1944, the impeccably dressed German General Herman Ramcke surrendered his paratroopers at Brest, France. He asked to see the credentials of the 8th Infantry Division's BG Charles Canham in order to surrender. The American general pointed to his filthy soldiers and stated "These are my credentials" adding to the mystique of the American infantryman and creating a division motto.

Despite the Germans destroying bridges and roads to slow the advance, Allied airpower punished any German that moved. The only setback was the Allied air operation "Market Garden". In order to stop the Germans from blowing up bridges, over 40,000 American and British paratroopers and equipment were dropped behind enemy lines in order to capture and hold key bridges until British tanks and infantry could assemble. The bridge at Arnhem in the Netherlands proved to be a "Bridge Too Far" with 18,000 Allied personnel captured or killed.

The US entered Germany in February 1945. GEN Eisenhower made the unpopular decision to allow the Soviets to capture Berlin. Ike reasoned the cost would be prohibitively high in lives. He was proved right when the Soviets lost 100,000 troops in the assault upon Berlin alone. The Nazis surrendered to the Soviets on 2 May 1945 and surrendered to the Allies on 7 May 1945. Hitler and his Third Reich had taken the German nation and its people into a catastrophic defeat.
