Purpose of Organization or Mission Statement and Services Rendered:

Brownsboro Alliance is a community organization that works to renew and reconnect the economy, environment and people of Brownsboro into a sustainable innovative community. The Brownsboro Trails continue to serve as a growing network further connecting and preserving the people and land for generations to come. The Brownsboro Trails link trails and roadbeds of individual landowners to create a natural trail system through the scenic farms of Brownsboro for hiking and horseback riding. The trails do require a minimal annual membership fee because we are given permission to traverse on private property. Guests are always welcome for a minimal fee with a signed release form. For other groups and non-profits, in most instances, the fee is waived with signed released forms; thus, serving their purpose to bring children, families, hikers, horseback riders to nature - providing fresh air, exercise within a natural classroom. Many educational opportunities and fun events are offered on the trails throughout the year including wildflower and tree walks, mindful meditation hikes led by local experts, night hikes, and wiking (wine and hiking!). Youth programs provide outdoor opportunities for various school and community groups from Oldham and surrounding Counties. The middle schoolers from the West End School – 38 boys and staff – were back on the trails this past October for hiking, experiencing the creek, nature at its best with a respite in fresh air and sunshine. They do enjoy the BATA Kids Adventure Trail. Local Boy Scouts continue to utilize the trails to hike at their leisure in preparation for their Philmont Trek competitions, service projects and badges. As stated previously, these kinds of groups and other non-profits are welcome on the trails at no cost to them.

The land is preserved for generations to come allowing the community the means to experience literally untouched, rustic forested woodlands in our own backyard. Nature is a powerful source of health both mentally and physically. Thus, Brownsboro Alliance maintains its commitment to the Brownsboro Trails, developing further trails, maintaining those trails, and seeking funding to do so.

Statement of Need for Project:

Since its installation in 2022, the BATA Kids Adventure Trail has been very popular with families, their children and adults. It has provided a more easily accessible tract with roped steps to a tributary of Harrod's Creek and the surrounding woodlands. It has been well received for quick hikes, and respites in nature without going too deep into the woodlands, providing solace for the mind and body.

BATA is very excited to submit a request for grant dollars to extend the BATA Kids Adventure Trail. This extension will allow for children to explore further stream life, observe limestone bluff habitat, wonder over a small "cave" and/or rock shelter and larger boulders, walk under large logs, and enjoy the beauty of the natural world.

Proposed Use of Funds to Remediate the Need:

The grant dollars will be used to plan and install this extension in the most ecologically safe way to protect this preserved land, not only accommodating for ravines and steep slopes but will help to retain slope integrity, prevent erosion, provide a wider trail for foot traffic and maximize trail stability.

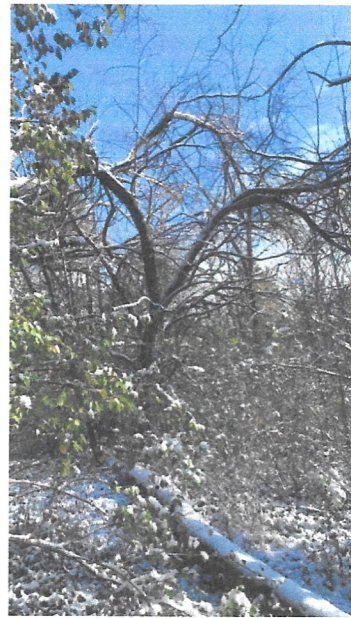
