Statement of Need

Community Chest of Oldham County helps around 400 individuals with emergency assistance each year. Our agency provides financial assistance for apartment rental, house payment and utilities (electric, gas, and water) as well as miscellaneous shelter/transportation needs. Food assistance is given to the elderly when the need becomes known. For health reasons or those with small children, we help with window air conditioners or water heaters at various times. Community Chest works with local agencies and churches to help coordinate payments of large client requests which require multiple agencies to pool funds.

Metro United Way discontinued funding our agency in 2025. We are currently seeking other funding sources. We developed a website in 2025 to help explain our purpose and to use in raising awareness and funds. Website is www.CommunityChestOC.org.

Please note close to 90% of the expenses incurred are in direct support of our clients. Only 10% of agency funds are administrative cost. Our agency operates from the Executive Director's home (keeping expenses low).

Proposed Use of Funds

Community Chest of Oldham County is asking for funding of \$3,000.00 to help individuals during the spring and summer months of 2026. This assistance will pay for EMERGENCY utility assistance needs. 100% of the grant money given will go directly to this assistance. Community Chest typically spends between \$15,000 to \$20,000 each year on utility assistance for clients to pay for electric, gas and water bills in all areas of the county. Our average utility assistance is \$250 per client.

Dear Applicant:

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).

We have further determined that you are not a private foundation within the meaning of section 509(a) of the Code, because you are an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

If your sources of support, or your purposes, character, or method of operation change, please let us know so we can consider the effect of the change on your exempt status and foundation status. In the case of an amendment to your organizational document or bylaws, please send us a copy of the amended document or bylaws. Also, you should inform us of all changes in your name or address.


