Statement of Need For Project:

The Arts Association of Oldham County is pleased to apply for a grant from the Oldham County Fiscal Court for the 2025 application for the 2026 granting year.

Our program goals fall under the category of **Arts and Humanities**, for an **Arts Outreach, Visibility & Initiative** designed to expand public access to the arts, enhance community-wide celebrations and increase educational engagement throughout Oldham County and surrounding counties visiting from a tourism perspective.

Our initiative comprises connected components:

1. **Mobile Arts Outreach and Festival Infrastructure** (*relates to “contribute to tourism in Oldham County”; “support community wide-celebration”; “encourage arts activity on the part of Oldham Countians”; “play an educational role for Oldham Countians”*)
2. **A Rotating Public Art Installation in the Oldham County Fiscal Court building** (*relates to “conduct activity on behalf of Fiscal Court”; “play an educational role for Oldham Countians”*)
3. **Inclusive Arts Education Programming for Youth and Individuals with Disabilities** (*“relates to encourage arts activity on the part of Oldham Countians”, play an education role for Oldham Countians, particularly students”*)

These complementary programs are designed as a fiscally responsible mode for delivering arts and humanities programs as widely as possible and encouraging community pride and an enhanced quality of life for Oldham Countians.

Proposed Use of Funds to Remediate the Need

Community Arts Visibility & Mobile Outreach (request: \$6500)

The Arts Association of Oldham County annually participates and produces multiple public art festivals and community celebrations each year. Grant funds will support the purchase of an enclosed Arts Outreach Trailer, that will be used as a Gallery on Wheels at our events or other community events. A scan of available inventory suggests that a cargo trailer with a side or rear door are currently priced in the \$4000 - \$6000 range through local dealers on gently used marketplace sites.

The trailer will also be used as shared infrastructure for storing and transporting artwork, signage, educational materials and festival supplies. It will be branded with signage to increase visibility and messaging about the importance of the arts to our community and will acknowledge the Oldham County Fiscal Court as a funding partner. The goal is to have

a flexible interior layout that can also be used as a small-scale pop-up exhibition space, allowing residents and tourists to engage directly our local arts scene, without having to come to a gallery. This makes our art accessible for all and reduces any stigma or intimidation that may exist for some walking into an art gallery, who may think art galleries are “too rich for my blood”.

We have the capacity to safely and securely store the trailer onsite in one of our parking spaces or on private property provided by a Board member, along with hitched transportation, and with the appropriate considerations for any additional necessary insurance.

Budget for Community Arts Visibility & Mobile Outreach:

- Enclosed cargo trailer, 5x8 to 6x12 (new or gently used): \$4,000 - \$5,000
- Registration, title and basic safety accessories (lock, wheel chock, hitch hardware): \$250
- Interior modular display outfitting (removable wall panels, hooks, racks, hardware): \$500
- Exterior wrap and wayfinding signage: \$750

Civic Arts Educational Display (request: \$2000)

This grant request also includes the commissioning and acquisition of artwork by local artists to be hung as an ongoing exhibit at the Oldham County Fiscal Court building. This is a highly trafficked area for Oldham Countians and an art installation will beautify the space and showcase local talent.

The artwork selection will be done in collaboration with a to-be-established Fiscal Court Art Review Committee, which will provide input to best support the building’s design, historical context and civic goals.

We have the opportunity to refresh the pieces periodically to maintain public interest. The artwork can support student engagement as well with some pieces from students.

We would also be thrilled to participate in a public-facing ribbon cutting or unveiling for the public and/or media. This kind of an event could include artist recognition, brief educational programming (maybe with our new trailer?) and dignitary remarks from public officials.

Project Budget for Civic Arts Educational Display:

- Acquisition of original artwork by local artists (5-20 pieces depending on size and medium) - \$1500

- Exhibition materials (labels, mounting hardware, educational signage, QR codes, protective framing or lighting as needed) - \$500

Inclusive Arts Education & Outreach Programming (request: \$1500)

The Arts Association of Oldham County believes that art should be accessible for all and that individuals are lifelong learners – from youth to adulthood, no matter any natural born artistic abilities or not. To ensure access, grant funds for this outreach initiative, will support inclusive arts education programming at the Association’s Gallery 104. (With a funded trailer, this type of education could be mobile and conducted offsite at senior assisted living centers, halfway houses, foster home facilities and so forth.) These programs will focus on youth and adult learners and also provide education and adaptive programming for individuals with disabilities, encouraging hands-on creative expression.

Funds will support instructor stipends, program supplies and any adaptive materials needed.

Project Budget for Inclusive Arts Education & Outreach Programming:

- Teaching artist/instructor stipends (multiple workshops or sessions): \$750
- Supplies and consumable materials (many items are make-and-take): \$500
- Accessibility accommodations and outreach materials: \$250

Public Benefit and Impact Related to Our Proposed Initiatives

Communities with strong arts programs are healthier communities. Civic public/private partnerships are solid, fiscally sound models for strong community engagement, impactful tourism and general pride. Our proposed program initiatives accomplish the following:

- Expanding access to the arts for Oldham Countians and our neighbors
- Support local artists through commissions and sales, contributing to a stronger creative community
- Enhancing community-wide celebrations, festivals and civic loyalty
- Providing educational opportunities for learners of all ages and especially those struggling for access
- Increased public recognition of the Oldham County Fiscal Court’s investment in our community

Capacity

The Arts Association of Oldham County has a solid history and established reputation of delivering meaningful public arts programming and projects. We will maintain detailed document of expenditures, outcomes and public engagement and will fully report to the Oldham County Fiscal Court as needed.
