MISSION OF OUR ORGANIZATION AND SERVICES RENDERED:

The mission of the Humane Society of Oldham County is to serve O.C. citizens and animals by finding permanent homes for unwanted, abused and homeless animals, promoting the humane care of animals through education, implementing programs that aid pet owners and lowering the number of unwanted animals through spay/neuter programs.

Services and programs include:

\*Low cost Spay/Neuter clinics for those who cannot afford a full service veterinary hospital. We help Oldham County citizens, Oldham County Animal Control and Rescues from other counties who don't have these services available to them .

\*We rescue and re-home unwanted, abused and homeless animals.

\*Hungry Paws is a once a month pet food bank for qualified owners who are having trouble feeding their pets.

\*Meals on Wheels for Hungry Paws delivers pet food, supplies, vaccines and a pet well check to homebound seniors who are having trouble taking care of their pets.

\*TNR- HSOC also helps businesses and individuals trap colonies of strays ( community cats) on their property. Some of those cats are relocated into our successful Barn Cat Relocation Program for strays and ferals. The cats get a new safe home and the owners get help with rodent control.

## STATEMENT OF NEED AND PROPOSED USE OF FUNDS FOR OUR PROJECTS:

### CAT QUARENTINE CAGES: \$5,132

In the past two years, the number of cats entering our shelter has increased by 61%. As intake continues to rise, our quarantine room has become one of the most critical—and most strained—areas of our facility. We urgently need additional veterinary-grade quarantine cages to safely accommodate this growth. Every cat entering our shelter must remain in quarantine for a minimum of two weeks, fully isolated from the general cat population. This is not optional; it is a necessary safeguard to protect against the spreading of diseases. The quarantine room is equipped with a specialized air filtration system designed to reduce airborne viral transmission, and veterinary grade housing units that can be reconfigured. These are solid on 5 of the 6 sides and meant to reduce exposure from the animals in the adjacent units. They are easily cleaned and sterilized.

Cats entering quarantine are often sick, carrying parasites, severely soiled, or suffering from undiagnosed illnesses. Because of this, these cats CANNOT be housed in other areas of the shelter, cannot share cages, or share litter boxes without putting the entire population at risk.

Insufficient quarantine housing creates the possibility of a disease outbreak that could force a full shelter shutdown. Two years ago, our shelter experienced exactly this scenario when a rare and dangerous virus spread, resulting in a building-wide quarantine and a closure lasting more than a month. Additional quarantine cages are a critical line of defense against spreading disease and shelter-wide shutdowns.

### SPAY/NEUTER CLINIC SUPPORT : \$2,728

Having our own diagnostic equipment in-house saves us from having to send our labs elsewhere for testing, which  
A) saves us money and B) prevents diagnostic and treatment delays on our sick patients.

We are requesting an LED Trinocular microscope with moticam wifi camera , cost \$2,063 and a veterinary culture incubator for diagnosing bacteriologic cases. Cost, \$665.

### MEALS ON WHEELS FOR HUNGRY PAWS PROGRAM: \$1,200 ( \$100 per month for 1 year)

This program delivers pet food, supplies like litter, vaccines and a pet well check to Oldham County homebound seniors on a fixed income who are having trouble taking care of their pets. And if the animal needs veterinary care they will be referred to our clinic at no cost. Seniors can make great pet parents, they have the time to devote to the animals and often need their companionship as much as the pet needs a home. What they struggle with is the high cost of pet food and veterinary care. We are asking OCFC to help supplement our cost for pet food, supplies, and vet care for this special program for one year.

USE OF FUNDS FROM 2024 OCFC GRANT WE RECIEVED:

The Humane Society of Oldham County received grant funds of \$ 2,875 last year. That was for help with our Meals on Wheels for Hungry Paws program, Visiting Vaccines and Compassionate Medical Care program, our Hungry Paws food bank, and for supplementing the many reduced and free spay/neuters we do for the community.

This year we performed 2,587 low-cost spay/neuters , the largest one year number in our history! We gave out 58,000 pounds of pet food to people struggling to feed their pets this year. Below are two OC seniors in our Meals on Wheels for Hungry Paws program. Both are very grateful for our help!

Based on information supplied, and assuming your operations will be as stated in your application for recognition of exemption, we have determined you are exempt from Federal income tax under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3).



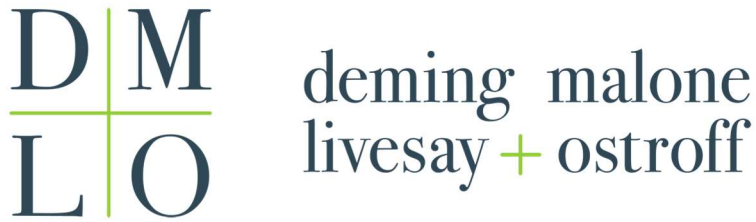
