Magistrate Woosley shared Parks Departments Letters from Santa program as well as the Breakfast with Santa event on December 13th.


Magistrate Theiss shared that he has time to reflect on the purchase of Stewart Lane property and requests we hire an architect to work with to make this the best park in Oldham County.
