APPROVAL OF AGENDA:

Motion made by Magistrate Haunz and seconded by Magistrate Jeffries to approve the agenda. Judge Voegele requested to add a new item “b” under Contracts and Resolutions, related to approving opioid abatement fund disbursements to Operation Parent and Oldham County Health Department. Motion carried unanimously.

COMMITTEE REPORTS & RECOMMENDATIONS:

Opioid Abatement Funds

Judge Voegele presented three requests for funding: one from Operation Parent and two from the Oldham County Health Department and Youth Linking Oldham County.

Motion made by Magistrate Woosley and seconded by magistrate Jeffries to approve \$88,277.11 for Operation Parent to have handbooks printed for all 8539 school households in Oldham County. Motion passed 8-1, Magistrate Likins voted no. **Exhibit #6 9/16/2025.**

Motion made by Magistrate Woosley and seconded by Magistrate Hawkins to approve up to \$24,370 to send 10 Youth Linking Oldham County members and 4 staff members/chaperones to the February 2026 CADCA conference in Washington DC. Motion carried unanimously. **Exhibit #6 9/16/2025.**

Motion made by Magistrate Woosley and seconded by Magistrate Haunz to approve up to \$4,500 to the Oldham County Health Department for the Opioid Diversion Prevention – Medication Lock Box program. Motion carried unanimously. **Exhibit #6 9/16/2025.**

Public Library Board

Motion made by Judge Voegele and seconded by Magistrate Woosley to appoint Laurie Anne Roberts to the Library Board, for a term to expire 10/1/2029. Motion carried unanimously. **Exhibit #8 9/16/2025.**

Judge Voegele requested to go into closed session pursuant to KRS 61.810(1)(B) regarding discussions concerning the acquisition of real property by a public agency for public use when publicity would be likely to affect the value of the specific piece of property subject to the discussions with Deputy Judge Kevin Nuss and Mark Nasser also in attendance. Motion made by Magistrate Likins and seconded by Magistrate Haunz at 3:19pm. Motion carried unanimously.

Motion made by Magistrate Haunz and seconded by Magistrate Woosley to return from closed session at 4:36pm. Motion carried unanimously.

Motion made by Magistrate Haunz and seconded by Magistrate Likins to allow Judge Voegele to enter into negotiations to purchase a piece of property, for the benefit of Oldham County. The purchase price will be ratified at a later court meeting. Motion carried 8-1, Magistrate Dye voting no.

County Engineer, Jim Silliman, notified the court two of the three bids were ready to be awarded.

Motion made by Magistrate Haunz and seconded by Magistrate Jeffries to award the 6221 Perrin Drive and 6211 Breeze Hill Rd Drainage Improvement Project to Allterrain Paving and Construction LLC, for the lowest bid of \$39,995.00. Motion carried unanimously.

Motion made by Magistrate Jeffries and seconded by Magistrate Haunz to award the Fall 2025 Group 1 County Paving project to LIBS Paving Co Inc, for the lowest bid of \$1,979,181.50. Motion carried unanimously.

Magistrate Theiss shared the recent information provided to him by Caryn Hunstinger regarding the Hope Health Clinic, and the good they do for the community.

Magistrate Woosley shared an upcoming event put on by the Hope Health Clinic, the Give For Good Louisville Day which is on September 18th. Share upcoming Bunco nights at the John Black Community Center, on October 9, November 20 and December 11. The upcoming Spooktacular event on October 18th at Wendall Moore Park and the Turkey Trotter 5k on November 8th, also at Wendall Moore Park. Super Drews Crew will be at Third Turn in Crestwood on November 8th. Adopt Me Bluegrass will have their annual Halloweenie Walk at Maples Park on October 12.

Magistrate Jeffries announced the Ballardsville Water Tower is being painted. Also announced the burn ban will likely not be lifted on October 1, due to dry conditions. Also announced the Oldham County Beef Cattle event coming up at Fox Hollow Farm on October 7th.

Magistrate Haunz echoed the information about the dry conditions and burn ban likely not being lifted on October 1. Mentioned the food drive to start likely the beginning of October. Reminded the public about the Household Hazardous Waste event coming up on October 4 at the County Road Department.

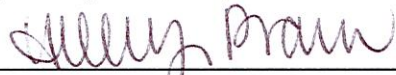
Magistrate Logsdon shared his hope for gas prices to drop, soon.
